

## BEDFORD BOROUGH COUNCIL (KEMPSTON) (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2018 (AMENDMENT NO.5) ORDER 2019

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Bedfordshire Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into force on 5<sup>th</sup> September 2019 and may be cited as the "Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 (Amendment No.5) Order 2019".
- 2. As from the date upon which this Order comes into force the provisions of the "Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended" shall be varied as follows:
  - (i) The plan schedule reference "Grid Reference F 41 Revision No: 1" shall be deleted and the plan schedule reference "Grid Reference F 41 Revision No: 2" shall be inserted.
- 3. This Amendment shall be read and construed as one with the "Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018".




## STATEMENT OF REASONS
