

# BEDFORD BOROUGH COUNCIL (20MPH SPEED LIMITS) (HIGH STREET AND VICARAGE GREEN, THURLEIGH) ORDER 2023

#### **STATEMENT OF REASONS**

Bedford Borough Council has received a request to reduce speed limits from 30mph to 20mph on High Street and Vicarage Green in Thurleigh. The proposed 20mph speed limits are intended to help provide a safer road network for all highway users, including pedal cyclists, motor cyclists, school children and other pedestrians in the general vicinity of Thurleigh Primary School.



## BEDFORD BOROUGH COUNCIL (20MPH SPEED LIMITS) (HIGH STREET AND VICARAGE GREEN, THURLEIGH) ORDER 2023

BEDFORD BORQUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (20mph Speed Limits) (High Street and Vicarage Green, Thurleigh) Order 2023" and shall come into force on 13<sup>th</sup> February 2023.
- 2) As from the date upon which this Order comes into force the following Order shall be revoked:
  - BEDFORD BOROUGH COUNCIL (30MPH AND 40MPH SPEED LIMITS) (THE PARISH OF THURLEIGH, BEDFORD) ORDER 2018
- 3) As from the date upon which this Order comes into force any length of road specified in the Schedule to this Order shall cease to be a restricted road for the purposes of Section 81 of the Act.
- 4) As from the date upon which this Order comes into force no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on any length of road specified in the Schedule to this Order.
- 5) As from the date upon which this Order comes into force the speed limits imposed by this Order shall supersede any previous speed limits on any length of road specified in the Schedule to this Order, and any part of any previous speed limit Order shall hereby be revoked insofar as it applies to any length of road specified in the Schedule to this Order.
- 6) No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.

#### SCHEDULE

Lengths of roads upon which a 20mph speed limit shall apply:

(i)	The entire length of the road.
