

PUBLIC NOTICE

BEDFORD BOROUGH COUNCIL PROPOSE A NEW ZEBRA CROSSING AND PARKING RESTRICTION CHANGES ON PUTNOE LANE, BEDFORD

Reason for Proposal:

Under Section 23 of the Road Traffic Regulation Act 1984 (as amended) Bedford Borough Council propose to establish a new zebra crossing in Putnoe Lane, Bedford. The proposal is intended to improve pedestrian safety in Putnoe Lane, as a zebra crossing will provide an identified, controlled crossing point for pedestrians.

To facilitate the carriageway lining associated with the new zebra crossing, it will be necessary to revoke some double yellow lines. The double yellow lines will be replaced by the requisite zebra crossing zig-zag lines.

Effect of the Proposal:

1. To establish a new zebra crossing at the following location:-

	Putnoe Lane, Bedford		
(i)	Between Brecon Way and Putnoe Street, the centre of the zebra crossing		
	being approx. 29.2 metres northeast of the centre of Brecon Way.		

2. To revoke double yellow lines on the following length of road:-

Α	Putnoe Lane, Bedford			
(i)	On both sides of the road, extending from a point approx. 9.7 metres			
	northeast of the projected centre of Brecon Way for a distance of approx. 39.5			
	metres in a north-easterly direction.

The documents will be placed on deposit until 6 weeks after the Order is made or until it is decided not to continue with the proposal. BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.91) Order 2023" and shall come into force on 7th August 2023.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
 - (i) The plan schedule reference "Grid Ref: N 19 Revision No: 5" shall be deleted and the plan schedule reference "Grid Ref: N 19 Revision No: 6" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.




