REFERENCE: Stevington Neighbourhood Development Plan

On 17th September 2013 at the Stevington Parish Council meeting, it was resolved to prepare a Neighbourhood Development Plan for the parish, and a copy of that resolution is enclosed with this letter.

Pursuant to this resolution, and sections 61F and 61G of the Town and Country Planning Act 1990 (the Act) and regulation 5 of Neighbourhood Planning (General) Regulations 2012 (the Regulations), we hereby formally apply to Bedford Borough Council for the designation of the whole of this parish as a Neighbourhood Area. Please find enclosed a map based on the Ordnance Survey and Borough supplied data, and showing the area of the Parish of Stevington applied for outlined in red. (Please note that it is the OS/Borough data that is to be used to define the area – the outlining is merely for information to indicate which boundaries are to be used).

In accordance with regulation 5(b) we assert that it is desirable that the whole of Stevington be designated as a Neighbourhood Area so that a more integrated approach to planning at the neighbourhood level can be achieved.

In accordance with regulation 5(c) we assert that Stevington Parish Council is the relevant body for the purposes of s61G of the Act.

Having regard to *inter alia* s61G (3)(a) of the Act we believe the area applied for has not been already designated as a Neighbourhood Area and that the areas applied for by Stevington and neighbouring parishes do not overlap.

STEVINGTON PARISH COUNCIL – EXTRACT OF MINUTES OF MEETING ON 17TH SEPT 2013

<u>4). Neighbourhood Development Plan (NDP)</u> – BS said that the evidence suggests that we need a Neighbourhood Plan, and there would be a great vacuum without one. Our village plan is fine as a baseline.

NDPs have to dovetail with existing BBC's local plan and Core Planning Policies. PO explained that the BBC has already started the next round of plans ready for 2021; we can seek to comment and/or influence BBC's proposals if we have completed our own NHP.

PO explained that as part of a NDP we would need to talk to neighbouring villages, i.e. Oakley and Pavenham to look at landscape around the River Ouse and consider a separate overarching plan for that.

Once registered and agreed by the Executive, Jill Cowey and Martin Tidy of the BBC will offer support. There is a £7K grant, with no deadline, which may help towards survey and specific costs involved in the NDP, and the BBC have to pay for an assessment and a referendum.

BS asked if there was a template for NDPs but PO said now that the A & Ds were finalised, the BBC have time to devote to this, and there may be in the future. A sub-committee will be set up to do a more detailed feasibility study and explore the terms of reference for a NDP. BS and JT had already volunteered and PO'F agreed to join them: HP agreed to send out copies of the terms of reference already existing for sub-committees, and the final make-up of the committee will be confirmed at the next PC meeting. The TOR allows for the provision of non-members of the PC being appointed to this committee, thus engaging with the village as much as possible for help as and when specialist expertise is required.

Resolved:

To prepare a Neighbourhood Plan.


