### BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE NEW PARKING RESTRICTIONS ALONG HILLGROUNDS ROAD, KEMPSTON

#### Reason for Proposal:

Bedford Borough Council has received a request from Ward Councillors for new parking restrictions along Hillgrounds Road, Kempston. This is in response to concerns raised over inconsiderate parking around the entrance to Kempston Rovers Football Club which affects visibility and safety. This restriction is intended to remedy that.

#### **Effect of the Order:**

1. To introduce "No waiting at any time" restrictions (double yellow lines) on the following length of road:

Α	Hillgrounds Road, Kempston	
(i)	On its north-eastern kerb, from a point approx. 43.5 metres north-west of th	
1	projected centre of Prentice Gardens for a distance of approx. 35 metres in	
	north-westerly direction.

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 (Amendment No.18) Order 2023" and shall come into force on 19<sup>th</sup> June 2023.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended shall be varied as follows:
  - (i) The new plan schedule reference "Grid Ref: Kemp G 32 Revision No: 0" shall be inserted.
- This Amendment shall be read and construed as one with the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended.




