



## PUBLIC NOTICE

### **BEDFORD BOROUGH COUNCIL** **BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE NEW PARKING** **RESTRICTIONS ALONG HILLGROUNDS ROAD, KEMPSTON.**

#### **Reason for Proposal:**

Bedford Borough Council has received a request to introduce some parking restrictions in Hillgrounds Road, Kempston. The restrictions will be located at several junctions. These locations will be kept free of parked vehicles by the restrictions, thus improving visibility and helping to ensure a safer road network for all highway users.

#### **Effect of the Order.**

- 1. To introduce 'No waiting at any time' restrictions (double yellow lines) on the following lengths of roads:**

<b>A</b>	<b>Hillgrounds Road, Kempston</b>
(i)	On its southern kerb, from a point approx. 17 metres west of the centre of Hartwell Drive to a point approx. 17 metres east of the centre of Hartwell Drive.
(ii)	On its southern kerb, from a point approx. 99.5 metres east of the centre of Hartwell Drive extending into the southern entrance to the parking area, on both sides, for a distance of approx. 16 metres in an easterly direction.
(iii)	On its southern kerb, from a point approx. 52 metres west of the centre of Ely Way, including around the extent of the turning head, for a distance of approx. 20 metres in an easterly direction.
(iv)	On its southern kerb, from a point approx. 10 metres west of the centre of Ely Way to a point approx. 10 metres east of the centre of Ely Way.
(v)	On its southern kerb, from a point approx. 33 metres east of the centre of Ely Way, including around the extent of the turning head, for a distance of approx. 17 metres in an easterly direction.
(vi)	On its southern kerb, from a point approx. 14 metres west of the centre of Butler Way to a point approx. 14 metres east of the centre of Butler Way.
(vii)	On its southern kerb, from a point approx. 56 metres east of the centre of Butler Way extending into the southern entrance to the courtyard to the extent of the adopted highway, on both sides, for a distance of approx. 19 metres in an easterly direction.
(viii)	On its southern kerb, from a point approx. 13 metres west of the centre of Prentice Gardens to a point approx. 13 metres east of the centre of Prentice Gardens.
(ix)	On its northern kerb, from a point approx. 17 metres east of the centre of Hartwell Drive extending for a distance of approx. 60 metres in a westerly direction.

<b>B</b>	<b>Hartwell Drive, Kempston</b>
(i)	On both sides, from the southern side of Hillgrounds Road for a distance of approx. 20 metres in a southerly direction.
<b>C</b>	<b>Ely Way, Kempston</b>
(i)	On both sides, from the southern side of Hillgrounds Road for a distance of approx. 5 metres in a southerly direction.
<b>D</b>	<b>Butler Way, Kempston</b>
(i)	On both sides, from the southern side of Hillgrounds Road for a distance of approx. 10 metres in a southerly direction.
<b>E</b>	<b>Prentice Gardens, Kempston</b>
(i)	On both sides, from the southern side of Hillgrounds Road for a distance of approx. 10 metres in a southerly direction.
