

#### **PUBLIC NOTICE**

## BEDFORD BOROUGH COUNCIL PROPOSES TO INTRODUCE PARKING RESRICTIONS ON MUIRFIELD AND ITS SIDE ROADS, GREAT DENHAM

**Reason for proposal:** Bedford Borough Council has received a request from Great Denham Parish Council to introduce parking restrictions along the entire length of Muirfield and at the junction of its side roads, restricting parking during school drop off and collection hours. Concerns are raised regarding inconsiderate and obstructive parking within these roads.

#### **Effect of the Order:**

## 1. To introduce no waiting Mon-Fri, 8am – 9.30am and 3pm – 4.30pm restrictions on the following lengths of road

#### A Muirfield

The entire length of road extending from a point 10 metres south west of its junction with Kingswood Way.

PLEASE NOTE: That the two lay-bys along this length of road will remain unrestricted

#### **B** Lytham Place

On both sides of the road extending a distance approximately 10 metres in a western direction from its junction with Muirfield

#### **C** Mentmore Close

On both sides of the road extending a distance approximately 10 metres in an eastern direction from its junction with Muirfield

BEDFORD BOROUGH COUNCIL in exercise of the powers under section 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Bedfordshire Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

This Order shall come into operation on \*\*2015 and may be cited as "Bedford Borough Council (Great Denham Controlled Parking Zone and Prohibition and Restriction of Waiting, Loading and Stopping) Order 2015 (Amendment No.1) 2015.

As from the date upon which this Order comes into operation, the provision of the "Bedford Borough Council (Great Denham Controlled Parking Zone and Prohibition and Restriction of Waiting, Loading and Stopping) Order 2015 shall be varied as follows:

(i) The plan schedule reference "Grid Reference \* Revision No \*" shall be deleted and "Grid Reference \* Revision No \*" shall be substituted

This Amendment shall be read and construed as one with Bedford Borough Council (Great Denham Controlled Parking Zone and Prohibition and Restriction of Waiting, Loading and Stopping) Order 2015

#### **STATEMENT OF REASONS**

Bedford Borough Council has received a request from Great Denham Parish Council to introduce parking restrictions along the entire length of Muirfield and at the junction of its side roads, restricting parking during school hours. Concerns are raised regarding inconsiderate and obstructive parking within the road.

The Parish Council highlights the available parking which has been made at the Park and Ride site which is within the vicinity of the school. However, some motorists appear to not use the facilities and park within the nearest residential streets.

It is therefore proposed that restrictions are introduced along the entire length of Muirfield, and also extending into the junctions of the adjoining roads by a length of 10 metres. There are two lay-bys along the Muirfield which will remain unrestricted. The restrictions will be in force from Mon-Fri between the hours of 8am till 9.30am and 3pm till 4.30pm.
