Appendix A

Motion to Full Council on East West Rail / BBC Actions

This council notes:

- East West Rail's sudden and recent decision to propose the demolition of homes on Ashburnham Road.
- Residents and businesses have been shocked and upset by this decision.
- EWR failed to communicate these plans with local Councillors who would have advised a different approach

This Council believes:

• Demolition of those properties is not required for a final design of a new station for Bedford, even if it includes space for East West Rail trains, as shown by EWR's previous consultation documents, based on station designs they considered workable. Neither is demolition necessary for the process of building the new station.

- That faster construction is not sufficient justification for the demolition of people's homes, whether on Ashburnham Road or in the Poets estate.
- That outright opposition to building of East West Rail is not likely to convince the Department of Transport to take any course of action that will avoid demolitions of homes in Ashburnham Road and the Poets estate.

| 1.0 | To do all it can to support residents whose homes are proposed to be demolished. | With the lack of engagement from EWR and failure to be transparent BBC has chosen to develop an independent engagement plan for residents and businesses impacted by the emerging EWR proposals. An initial phase of engagement has commenced focusing on those properties within Ashburnham Road identified for CPO under the amended safeguarding notice zone, with other phases to follow. Meetings with Landlords and Tenants has been scheduled for 9 th and 15 th December and BBC has been engaging with the affected businesses and GP surgery on a One-to-one basis. |
| 2.0 | To investigate designs for Bedford station that will provide the most convincing case that even if East West Rail is built going through Bedford station, there is no need to demolish homes on Ashburnham Road. | As yet the Council has not been provided with the relevant 'technical note' which identifies EWR's justification for requiring the demolition of properties on Ashburnham Road. This was first promised to the Council in August 2025, and continues to be requested by the lead officers on this workstream, and it is a standing item on this Task Group's agenda. Officers continue to seek further clarity on the emerging designs for Midland Station, clarify the stage of option selection EWR has currently reached and to urgently request again that the 'Technical Note' be provided for review by BBC to understand the options that have been considered and discounted. To commission specialist rail consultancy support to analyse EWR's technical note, and identify any |

| | | viable alternative approaches to station design at Bedford Midland. Given the ongoing delays by EWR in issue of this 'key' information, this will delay the Council in providing the necessary assessment for this proposal which has been put forward by EWR. Officers continue to raise this |

| 3.0 | To also investigate options for the railway and construction that will similarly obviate the need to demolish homes in the Poets estate, even if East West Rail is built going north out of Bedford Station before heading east. | Officers continue to seek clarity on the service assumptions that EWR argues strengthen the case for their '6 tracks' proposal, following the announcement of Universal., and to present further challenge to the 6 track proposal. Officer will seek to commission a further review using specialist rail consultants (expected to start January 2026), exploring alternative approaches to track layout that would obviate the need for EWR's proposed additional tracks. Officers continue to raise this point with EWR at relevant |

As a result there is a risk that this could delay BBC in providing clear advisory response on the current designs. Officers continue to raise this point with EWR at relevant EWR meetings. |

When preparing a response to any consultation about the Development Consent Order that East West Rail propose to seek, or equivalent consent under new planning law, to oppose all demolition of homes proposed, but given the amount committed to the route outline, the council will not seek to oppose the building of East West Rail overall, nor oppose it taking a route that goes through Bedford's main station (without the need for trains to reverse in Bedford).

BBC will continue to oppose and challenge the requirement for demolition of residential properties and ensure the requisite BBC subject experts attend and suitably challenge EWR at the various EWR meetings as the designs evolve to query/challenge/critique/support as appropriate.
