1	ST confirmed that it will not be possible to achieve a firm commitment on use of 'rail land' in time for the Trust's Elective Hub planning submission. This rules out rotation of the EH and moving it away from Britannia Road to increase pavement width. Noted that the planning app will therefore have to rely on Trust owned land for the building footprint, with continued use of leased land for parking and access.	Trust design team to progress planning submission accordingly.	JP
2	JF presented refined WW+P station work, including review of ped flow analysis and platform capacity. Island platform with unpaid bridge connection is still the preferred scenario, pending further engineering testing for track alignment scenarios.	N/A	
3	JF advised that the EWR strong preference is for station servicing to happen from the western side (Trust) rather than east. This would include deliveries, waste collection, etc – type of vehicle to be confirmed, likely rigid axle. Diagrams presented illustrating use of MSCP access road to a spur behind the Elective Hub and future Medical Building, for shared servicing access for station and Trust.
