1. Welcome by the Chairman

The chair welcomed everyone to the meeting.

AnP confirmed that the print room are drawing up the relevant tags and waymarkers. Leaflets will be produced and relevant info will be uploaded on to the Council website. AnP confirmed that as the project is an ongoing project, more walks can be added, but final routes must be agreed by the end of Feb 2025.

AnP confirmed that some payments from the Active Rural Grant had been made. Great Barford have received a grant to resurfacing.

BBC are submitting 4 schemes for consideration. AnP confirmed the funding ceases in March 2025

LAF member to provide suggestions for future schemes ie routes to be improved/upgraded/new routes to be added to DMS for when future money becomes available.

3. LCWIP & NCN51

Statement from Peter Simons;

"Aspects of mapping and survey methods discussed with local stakeholders. Software being procured, which will allow people to place notes on a live online map. It is hoped this will be ready mid-November. LAF will be notified accordingly".

AP confirmed NCN51 is progressing. Design work has commenced and route has been agreed.

B&MKWT are looking to route the waterway on a similar line to NCN51. The aim is for the waterway to reach Wootton from Bedford when funding is available.

LAF agreed this will be an ongoing agenda item.
