

<u>BEDFORD BOROUGH COUNCIL</u> <u>OFF STREET PARKING PLACES ORDER 2019</u> (AMENDMENT NO.7) ORDER 2025

Bedford Borough Council ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 32, 35(1) and 35(3) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended ("the Act"), the Traffic Management Act 2004, The Civil Enforcement of Parking Contraventions (Bedford) Designation Order 2009 and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council Off Street Parking Places Order 2019 (Amendment No.7) Order 2025" and shall come into force on 28th July 2025.
- 2) As from the date upon which this Order comes into operation the provisions of the Bedford Borough Council Off Street Parking Places Order 2019 as amended shall be varied as follows:
 - (i) The sections listed in Schedule 1 to this Order shall be inserted.
- This amendment shall be read and construed as one with the Bedford Borough Council Off Street Parking Places Order 2019 as amended.

STATEMENT OF REASONS

Bedford Borough Council has received a request from Ward Councillors to change the unused Zone X and Zone XR parking bays in Boswell Place, Bedford for residents of the area to use. Converting the unused bays (reserved for use by businesses) to Zone D would provide additional residential parking in an area of high demand. Some of the existing Zone X parking bays will be retained for use by businesses.
