THIS ORDER is made by the Bedford Borough Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interest of the owners of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the footpath should be diverted.

The Landowners have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the footpath into a fit condition for use by the public.

BY THIS ORDER:

- The public rights of way over the land situated in the environs of "Old Farm Cottage, Old Ways Road", in the Parish of Ravensden and shown by a bold continuous line between Points A -B on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 7 (seven) days from the date of confirmation of this Order.
- 2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the same rights over the land referred to in paragraph 1 above, in respect of their apparatus under, in, upon, over, along or across the said land as they had immediately before the date of confirmation of this Order.

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

i. That length of Public Footpath numbered 25 in the Parish of Ravensden in the environs of "Tycroes Farm," Ravensden commencing from a point where it has a junction with the unaffected part of Footpath 25 approximately 143 metres south-west of the residential property known as "Old Farm Cottage" Ravensden at Ordnance Survey Grid Reference (OSGR) TL 0702/5386 shown as Point A on the Order Map and running in a north east direction for approximately 152 metres to OSGR TL 0711/5398 shown as Point B on the Order Map

The Definitive Statement records no width for the Footpath for this section. For the avoidance of doubt, it is intended for this Order to stop up the length of Public Footpath described above in its entirety.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

i.A length of Public Footpath to be created in the Parish of Ravensden in the environs of "Tycroes Farm" Ravensden commencing from a point where it has a junction with the unaffected part of Footpath 25 approximately 143 metres south-west of the residential property known as "Old Farm Cottage" Ravensden at Ordnance Survey Grid Reference (OSGR) TL 0702/5386 shown as Point A on the Order Map then running in a generally north- east direction for approximately 114 metres and then north for approximately 14 metres and then north-east for approximately 26 metres where it connects to the public road known as Old Ways Home shown as Point C on the Order Map at OSGR TL 0710/5399.

The new length of Public Footpath described above shall have a width of 1.5 (one and a half) metres throughout.
