BEDFORD BOROUGH COUNCIL (STEWARTBY: PART OF FOOTPATH No. 3) PUBLIC PATH EXTINGUISHMENT ORDER 2023

This Order is made by the Bedford Borough Council ("the authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

BY THIS ORDER:

1. The public right of way over the land situated in the environs of Rookery South Energy Facility, in the Parish of Stewartby and shown by a bold continuous line between Points A to B on the map attached to this Order and described in the Schedule to this Order shall be extinguished after 7 (seven) days from the date of confirmation of this Order.
2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the same rights over the land referred to in paragraph 1 above, in respect of their apparatus under, in, upon, over, along or across the said land as they had immediately before the date of confirmation of this Order.
3. This order may be cited as the "Bedford Borough Council (Stewartby: Part of Footpath No. 3) Public Path Extinguishment Order 2023".

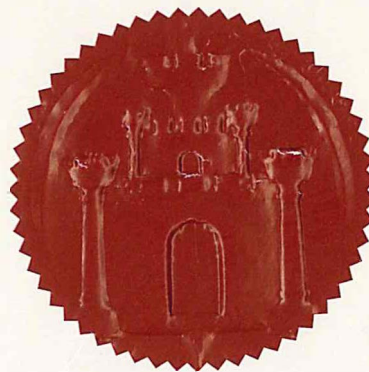

That part of Public Footpath number 3 Stewartby that commences from a cul-de-sac at Ordnance Survey Grid Reference (OSGR) TL 0240/4174 shown as Point A on the attached map then running in a generally south east direction for approximately 32 metres to a junction with the unaffected part of Footpath 3, Stewartby at OSGR TL 0242/4172 shown as Point B on the attached map.

The Definitive Statement records no information in respect of the width for Public Footpath number 3 Stewartby. For the avoidance of doubt the intention of the order is to extinguish the length of the Public Footpath described above in its entirety.
