Description of activity: Reduce the amount of funding provided to third sector organisations;

Chief Executive's - Revenues & Community Welfare

The Council has traditionally provided financial support to third sector organisations through grant funding. Third sector organisations are able to submit applications for funding each year to the Grants Committee of the Executive makes decision on awards. Normally decisions are made in February each year. There are a number of recognised disadvantages associated with this process;

- There is no certainty of funding for applicants from year to year limiting the organisations' ability to plan services and finances
- Applicants and the Council are required to allocate valuable resources each year to deal with the application process
- The applications significantly exceed the available funding each year
- The timing of the decision making process means organisation may not know the level of funding they will receive until shortly before the start of their financial year

Children's and Adults' Directorate - Adults Commissioning

The Adults Commissioning service manages strategic planning and service plans for all client groups. The service area also deals with Voluntary Organisation contracts covering a range of client groups, Healthwatch Bedford Borough and Carer's expenditure. There are also external contracts for shared services covering Domestic Violence, the Community Equipment Store and the Meals contract.

The service ensures a suitable range of social care services are commissioned, within available resources, to meet the identified needs of vulnerable adults and carers in Bedford Borough. It acts to shape the various social care markets, promote efficiency and innovation from providers and support partnership working across health and social care. The Service also undertakes social care procurement, contract management and decommissioning in response to performance and changing needs.

Proposed Changes to the Activity

Overview

It is proposed to review the current arrangements for third sector grant funding and commissioned work funding delivered through these two key service areas. It is proposed that all funding should move to commissioned services as it is considered that this approach will ensure that the limited funding available from the Council to third sector organisations is directed to assisting those residents most in need of the services offered through the third sector.

Commissioned services will also provide the following benefits to the Council:

- The services to be provided for the funding will be specified and commissioned through a competitive procurement process.
- Funding will be targeted at services and client groups identified as requiring assistance by the Council.
- A competitive process will ensure the Council, and local taxpayers, receive best value for money and will reduce the risk of 'duplication of funding' (i.e. funding being allocated to more than one organisation to provide similar services to similar client groups).

There will also be benefits for third sector organisations including the following;

- Greater security of funding as commissioned contracts will normally be issued for more than one year
- Reduced administration costs as there will be no requirement to submit annual funding requests
- The opportunity to bid for funding through a competitive commissioning process

It is recognised that some organisations may find the proposed reduction in funding challenging and, therefore, the Council will continue to provide non-financial support and assistance to third sector organisation, in conjunction with partners, to enable them to identify and apply for other sources of funding. It is also proposed to establish a cash-limited emergency hardship fund to enable assistance to be provided,

if essential, for a short-time in the event that funding is required by an organisation to avoid closure.

The specific proposals for each service are as follows:

Chief Executive's - Revenues & Community Welfare

It is proposed to discontinue grant funding for general advice services and third sector infrastructure support services. The Council will instead commission these services through a competitive commissioning process. Commissioning the services will ensure that local taxpayers receive the best value for money from the service providers and will provide assured funding to the service provider for the duration of the contracts; which are proposed to be for a minimum of three years. In turn this should allow the successful bidders to seek matched funding from other organisations. It is anticipated that a competitive process will result in savings of at least 10% compared to the current cost of grant awards.

It is proposed that the commissioned services will take effect from 1 October 2016 or as soon as practicable thereafter, to allow sufficient time to comply with appropriate procedures and regulations. In order to ensure continuity of service up to the commencement of the commissioned service it is proposed to extend the grant funding for the two existing providers for a further six months at 90% of the current award as shown in table 2 below. This transitional grant funding may be extended on a month by month basis for up to a further three months in the event that it is not practicable to complete the commissioning by 1 October 2016.

The grant funding provided to other organisations on a recurrent basis, currently £89,785, represents a small proportion of the Council's overall funding commitment to the third sector taking into account commissioned services, discretionary rate relief etc. Therefore, it is proposed to discontinue third sector grant funding, with the exception of Community Chest grants, from April 2016.

What consultation did you carry out with protected equality groups to identify your activity's effect on equality?

This proposal was subject to public consultation from 19 October to 14 December 2015. In summary 135 response forms were received which rated the proposal as follows:

The above included responses from Bedford CAB, ACCM, The Federation of Small Businesses, Great Barford Parish Council, BRCC and Bedfordshire & Luton Learning Partnership.

In addition written responses were made by the following organisations: CVS, Oakley Rural Charity, Autism Bedfordshire, BeCHaR (Prebend Day Centre) and Carers in Bedfordshire.

Two petitions were received in support of continuing the funding for the following organisations:

- Bedford Guild House 245 signatures
- Shopmobility 102 signatures

A third petition with 21 signatures was received requesting that the Council does not close the Prebend Street Day Centre (BeCHaR). The Council has no power to close the Prebend Street Day Centre and has not proposed to do so. It is, however, assumed that the petition relates to the proposal to reduce the funding to BeCHaR.

Written responses were also received in support of individual organisations as follows: Bedford Guild House (2 responses), Shopmobility (2 responses) and Autism Bedfordshire (1 response)

As part of the consultation a meeting was organised by CVS (1 December) with voluntary sector organisations that might be affected by this proposal, Council officers were in attendance to outline

the proposal and respond to questions (notes of this meeting are included in the Background Papers).

Representations from, or in support of, individual organisations all argue for the importance of the services provided by the voluntary body concerned and the impact any reduction in funding might have. In view of the large number of responses it is not possible to list all comments here and members are directed to the Background Papers which contains full copies of all matters that have been raised during the consultation. There are though some key overarching themes from the consultation:

- Positive impact of service on individual's health and well-being and if reduced the additional pressure on Council (social care and housing) services;
- Social value / return and general value for money of the voluntary organisations concerned for relatively small amounts of grant which in turn supports a vibrant third sector;
- Importance of local knowledge for any services that are commissioned in the future;
- Using some of existing (BRCC) grant to enable third sector infrastructure support service to be provided;
- What about exploring three year grant funding process?;
- Commissioning will be time consuming and will stifle innovation;
- Procurement exercise must be fair and robust and could disadvantage smaller organisations who do not have experience of commissioning;
- Importance of Council grants for attracting match funding;
- Rather than commissioning suggest 'strategic grant' approach;
- Smaller grants should remain in place; but support proposed transition arrangements;
- Hardship Fund acknowledged but this is a last resort and might support organisations that are unsustainable:
- Impact of reductions on services provided in rural areas;
- Council needs to signpost organisations to other funders

What does this evidence tell you about the different protected groups?

The evidence suggests that any reduction in funding could have a negative impact on a number of protected groups. Namely: older people (Bedford Guild House), people with disabilities (Shopmobility), race (Bedford African & Caribbean Forum and BRASS); religion or belief (Faith in

It is considered that small organisations that have been awarded a grant of less than £10,000, but which constitutes more than 10% of their income are likely to be most dependent on this source of income and. therefore, their funding will not be reduced in 2016/17.

Summary of analysis

In preparing this report, due consideration has been given to the Borough Council's statutory Equality Duty to eliminate unlawful discrimination, advance equality of opportunity and foster good relations, as set out in Section 149(1) of the Equality Act 2010.

The Council provides funding to third sector organisations through either grants or commissioning and in turn these third sector organisation provide services to residents. In many instances the third sector organisations provide service to persons from groups with protected equality characteristics. In some cases services are directed at specific groups, e.g. older persons, disabled persons etc. In other cases services are more universal, e.g. advice services, homelessness services, and are likely to include persons from groups with protected equality characteristics within their client groups.

Grant funding is provided on an annual basis and, therefore, organisation do not have any security of grant funding. However, it is recognised that organisation that have consistently received funding over the last four years may have a reasonable expectation that the funding will continue. In recognition of this potential expectation the reduction in grant funding will be phase over one year rather than immediately withdrawn.

Some organisations are more reliant than others on this source of funding and, therefore, the amount provided under the phasing will be higher for those organisations more dependent on this source of funding.

The Council's decision regarding funding will not directly impact on persons from groups with protected equality characteristics. The impact, if any, will depend on decision taken by each third sector organisations on how it will manage the effect on its finances. It is expected that organisations will take a rounded approach to dealing with reductions in funding including;

The Council has identified a range of mitigating actions, as set out above, which will assist in minimising any negative equality impact.

It is recognised that the funding provided in 2015/16 amounts to 5% or less of the annual income for five organisations, 12% for three organisations, 13% for one organisation and 35% for one organisation. It is expected that those organisations where the funding amount to up to 5% of the annual income will be able to adapt to the reduced funding without needing to consider reducing services.

Where income amounts to 12% or 13% it is expected that organisations will need to consider a range of options to adapt including sourcing additional funding, reviewing charging policies, making efficiency improvements and, potentially, minor reductions in services.

Shopmobility receives the highest amount of funding as a proportion of its income, 35%, through a third sector grant. However, it is noted that the organisation recorded a surplus in its annual accounts for each of the last four years, including a surplus of £11,157 for the year ended 31 March 2015. The organisation also has brought forward reserves of £45,000. Therefore, the organisation is in a position to absorb some reduction in funding without the need to reduce services. The organisation's higher level of dependence on grant funding is recognised and to mitigate any potential impact on service users Council officers will work with the organisation to seek to identify additional sources of funding including commercial sponsorship from town centre businesses.

Appendix A -

Proposed Criteria for Emergency Hardship Fund Awards

- 1. Only one application will be considered from each organisation.
- 2. The total funding provided in any one financial year through the hardship fund and transitional protection grant funding shall not exceed the third sector funding allocated to any organisation through the above services for 2015/2016 for existing service provision.
- 3. Applicants will need to demonstrate that without the award of emergency hardship funding it is likely that the organisation will have to cease operations or very significantly reduce the service the organisation provides solely due to the reduction in funding from the Council as a result of this proposal.
- 4. Applicants will need to demonstrate that funding has been sought without success from other sources (for example grant applications, sponsorship, and fees and charges for services, etc.) and that this has not generated sufficient income to maintain the financial viability of the organisations.
- 5. Applicants will need to demonstrate that consideration has been given to other measures to address the reduction in income, such as improving efficiency, reducing costs, increasing or introducing fees or charges and demonstrate that these measures are not viable.
- 6. Applications will only be considered where the organisation's available financial reserves are expected to be fully utilised (excluding any reserve required exclusively for statutory obligations arising from closure of the organisation e.g. redundancy payments).
- 7. Funding will not be provided to meet any costs associated with the closure or winding up of the organisation (e.g. redundancy costs) it is expected that organisation should have established suitable levels of financial reserves for this contingency.
- 8. All awards will be subject to the funding being available through the Hardship Fund. Once the Fund has been fully allocated no further awards will be considered.

The Council will determine the amount to be awarded and this may be less than the amount requested but not more.
