
Investigation Update

- We are continuing to work with key partners and specialist agencies to establish the cause of the explosion
- The explosion site will remain cordoned off in order to maintain the integrity of our ongoing investigation
- Officers from our community policing team will continue to conduct regular patrols in the area to support with reassurance amongst residents

Unfortunately, there is no update or established timeline regarding coroner's inquest.

Gas and Safety



What are we doing

- An overview of the underlying geology has been provided and a specialist team remains available
- Our team are undertaking repeat surveys to better understand the dynamic system. We continue to monitor for atmospheric and subsoil gas, and the transfer of ground to air gas
- The focus for monitoring this week has been the changes in atmospheric pressure starting on Fri 15th and forecast through to Tues 19th November
- We are increasingly turning our resources to interpreting the data and better understanding baseline levels for the area.



Our data (initial readings from 29th October)

- Observing fluctuations in readings over time
- Methane in soil 29th October
- To note:
 - Above baseline on Wagstaff
 CI
 - Above baseline Glenrose Av (outside/edge of cordon)



Latest data (BGS methane in air)

- Outside BGS
- In air measurements
- 15th November



Latest data (BGS soil gas)

- Soil gas readings
- 15th November
- Periodic extensions to the survey to the west of Cleat Hill assist with building an understanding of background in ground gas values



Summary

- At present our monitoring operations are recording low levels of gas, potentially below our current detection limits
- Latest BGS data supports the suggestion that gas flow from the borehole has been restricted, if not stemmed
- We have been able to record important data over the weekend during changing environmental conditions (including current fluctuations in atmospheric pressure). This work is ongoing as we seek to understand the potential impact that these environmental changes may have on gas levels and flow.
- The priority of BGS remains providing a robust set of data that the incident response coordinators can use in their decision-making, with our team remaining on site to continue monitoring work and collecting further readings.

Green will apply to those actions/milestones completed; amber will indicate a date where there is a need to complete action for all residents/households (understanding some actions, for some residents, will occur before milestones are completed; and Red will denote where actions not progressed within milestone aim. Issues log will be created where red is identified and this will be communicated to residents and relevant agencies.
