Emergency Response and Recovery



Bedfordshire Fire and Rescue Service

- BFRS remains at the scene to support partner organisations in the on-going activities in the cordon area.
- We continue to work as part of the multi-agency investigation team, focusing our work on the fire investigation.
- BFRS continues to manage the command and control and secretariat functions of the incident for the local resilience forum (LRF) to ensure all agencies work together to deliver a safe resolution.

Current Situation

- o Drilling fluid displaced by water and 15 metre plug at bottom of the borehole proved gas tight.
- $\circ~$ Cemented –20 metres of surface.
- o Gas readings under continuous monitoring.
- $\circ~$ Controlled sequence of operations.
- o Continuous monitoring and checks.

Next Steps

- 1. Allow cement to cure for at least 24 hours.
- 2. Establish monitoring pipe within the borehole, with pressure and gas flow capability.
- 3. Seal to surface.
- 4. Continue monitoring.

Cordon

- Cordon remains in place until all of the operations described have been completed.
- Monitoring will inform when the decision is made to allow people back into their homes.
- $\circ~$ This will be a multi-agency decision.

What are we doing

- We have provided an overview of the underlying geology and a specialist team has been on site since Monday 21st October
- Our team have conducted a first pass soil gas survey and are now undertaking a repeat surveys in order to monitor the dynamic system
- We are monitoring for atmospheric, subsoil and transfer of ground to air gas at outdoor locations
- We are increasingly turning resources to interpreting the data.






Our data

Summary

- At present our monitoring operations are recording relatively consistent reduced levels of gas
- Latest BGS data support the suggestion that gas flow from the borehole has been restricted, if not stemmed,
 - however ongoing work is seeking to understand the potential impact that changes in <u>environmental conditions</u> have on gas levels and flow (low pressure front/wind/rain and increased water pressure)
- BGS priority remains providing a robust set of data that the incident response coordinators can use in their decision-making, with our team remaining on site to continue monitoring work and collecting further readings.



Ground Source Heat Pump Association

Current Situation

This is the only occurrence of shallow gas known in over 25 years of GSHP operations in the UK, and <u>many</u> more years for water/mineral/site investigation drilling.

Advise to Residents

Microgeneration Certification Scheme (MCS). Sets and maintains Standards within the small-scale heat pump industry.

There have been 32,498 ground source heat pump installations registered with MCS since 2009 in the UK. The majority of these use boreholes.

At least as many boreholes drilled for large-scale, commercial (non-MCS) systems.

Ground Source Heat Pump Association

- The GSHPA will remain fully engaged and provide information to Residents and the Authorities throughout this process
- The GSHPA and others within the drilling sector will take learnings from this tragedy to ensure all operators are aware of the issues and, where required, procedures developed to minimise risks going forward

Bedfordshire Police

- We are continuing to work with partners to conduct a thorough investigation into the cause of the explosion. This includes reviewing any previous issues reported in the local area and ensuring sufficient resource of any post incident demand
- We have and will continue to support the partnership response by staffing the cordons and maintaining a police presence in the area. This includes the safe keeping of property keys and conducting regular patrols of the area
- In coordination with partners, we will also support with efforts to escort people inside the cordon to attend the properties when it is safe to do so



Housing:

• 31 households accommodated

Welfare Assistance:

- 43 households paid
- 96 clothing payments through our financial support package
 - Financial Package payments are being made on a weekly basis

Emergency Helpline:

- 331 calls answered in total
- Average waiting time on line 2mins

Bin Collections:

All black bins that we had access to were collected on Wednesday.

Postal Service:

• Currently post is being held at Ford End Road for collection, or being redirected to St Mark's Church and Community Centre.

Answers to some of the questions you raised:

- The brook was raised as a safety concern for playing children and young people. Our Environment Team reviewed the routes of overnight security with the company, and they agreed that they would increase the patrols in those areas.
- It was asked if once investigations are finished, does this get registered with land registry? Our Environment Team have advised that the questions answered as part of a search are set by the law society currently there is no question in relation to natural gas. A solicitor can submit their own questions as part of the search process. Aside from the search process, when you sell your house, you fill out a home report which goes to the buyer's solicitors, it may have to be declared there



Bedford Borough Council

Outstanding but in hand:

- Will there be full written guarantees for residents of safety. This could affect house sales/prices. *Richard Fuller MP taking forward*
- You said responsibility was for the borehole was with the drilling company. Will they be compensating us for the negligence? The Council to discuss and respond to residents when a response is available from Richard Fuller MP.
- What plans are there for monitoring gas levels after the operation to plug the borehole? *Contact made with Environment Agency.*
