### BEDFORD BOROUGH COUNCIL PROPOSES TO INTRODUCE A PROHIBITION OF RIGHT TURNS FROM DUDLEY STREET ONTO GOLDINGTON ROAD, BEDFORD

#### Reason for Proposal:

Goldington Road, Bedford is a very busy road. To improve road safety, it is felt that a Prohibition of Right Turn is necessary at this junction to prevent vehicles turning right across the busy stream of oncoming traffic.

#### **Effect of the Order:**

1. To introduce a Prohibition of Right Turn on Goldington Road, Bedford to prevent vehicles turning right from Dudley Street onto Goldington Road, Bedford.

## BEDFORD BOROUGH COUNCIL (GOLDINGTON ROAD, BEDFORD) (PROHIBITION OF RIGHT TURNS) ORDER 2025

BEDFORD BOROUGH COUNCIL in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- No person shall, except upon the direction or with permission of a Police Constable in uniform, cause or permit any vehicle to make a right turn into Goldington Road at its junction with Dudley Street.
- 2. Nothing in Article 1 shall apply to a vehicle being used for police, ambulance, fire brigade or Special Forces purposes in the event of an emergency.
- This Order shall come into operation on 11<sup>th</sup> August 2025 and may be cited as the "Bedford Borough Council (Goldington Road, Bedford) (Prohibition of Right Turns) Order 2025".
