## BEDFORD BOROUGH COUNCIL PROPOSE TO CHANGE PARKING RESTRICTIONS IN DUNHAM CLOSE, BEDFORD

## Reason for Proposal:

Bedford Borough Council has received an application from a developer to provide some parking bays as part of a Section 278 agreement with Bedford Borough Council. This will involve the removal of a section of an existing No Waiting restriction.

## Effect of the Proposal:

1. To revoke and remove the 'No waiting at any time' restriction (double yellow lines) on the following lengths of road:-

Α	Dunham Close, Bedford		
(i)	On its north-western kerb, extending from a point approx. 14.2 metres south-		
	west of the south-western side of the north-eastern arm of Dunham Close for		
	a distance of approx. 11.7 metres in a northerly direction.		
(ii)	On its south-eastern kerb, extending from a point approx. 19 metres south-		
	west of the south-western side of the north-eastern arm of Dunham Close for		
	a distance of approx. 32 metres in a south-westerly direction.

The documents will be placed on deposit until 6 weeks after the Order is made or until it is decided not to continue with the proposal. BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.57) Order 2023" and shall come into force on 13th November 2023.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
  - (i) The plan schedule reference "Grid Ref: N 33 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: N 33 Revision No: 2" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.


