

PUBLIC NOTICE

BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE SOME PARKING RESTRICTIONS IN HALL END ROAD, WOOTTON

Reason for Proposal:

Following a request from Wootton Parish Council, Bedford Borough Council proposes to introduce parking restrictions in Hall End Road, Wootton. The restrictions are required due to inconsiderate parking obstructing access to the adjacent properties.

Effect of the Order:

1. To introduce 'No waiting at any time' restrictions (double yellow lines) on the following length of road:

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Parish of Wootton, Bedford) (Prohibition and Restriction of Waiting and Loading and Stopping) Order 2016 (Amendment No.7) Order 2024" and shall come into force on 4th November 2024.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Parish of Wootton, Bedford) (Prohibition and Restriction of Waiting and Loading and Stopping) Order 2016 as amended shall be varied as follows:
 - (i) The plan schedule reference "Grid Ref: J 6 Revision No: 0" shall be deleted and the plan schedule reference "Grid Ref: J 6 Revision No: 1" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Parish of Wootton, Bedford) (Prohibition and Restriction of Waiting and Loading and Stopping) Order 2016 as amended.


