## BEDFORD BOROUGH COUNCIL PROPOSE TO EXTEND EXISTING PARKING RESTRICTIONS IN HAREWOOD ROAD, ELSTOW

## Reason for Proposal:

Bedford Borough Council has received a request from Ward Councillors for new parking restrictions in Harewood Road, Elstow. This is in response to concerns raised over inconsiderate parking at this location which affects access and vehicular movement, so these restrictions are intended to remedy that.

## Effect of the Proposal:

1. To install 'No waiting at any time' restriction (double yellow lines) on the following length of road: -

Α	Harewood Road, Elstow
(i)	Around the central island at its western end.

They will also be available for viewing on the council's website at www.bedford.gov.uk/proposedtro. The documents will be placed on deposit until 6 weeks after the Order is made or until it is decided not to continue with the proposal. BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.66) Order 2024" and shall come into force on 2<sup>nd</sup> September 2024.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
  - (i) The plan schedule reference "Grid Ref: K 35 Revision No: 2" shall be deleted and the plan schedule reference "Grid Ref: K 35 Revision No: 3" shall be inserted.
- This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.

## **STATEMENT OF REASONS**






