## Data Protection Privacy Statement - The administration and payment of Housing Benefit including the recovery of overpayments.

In order to deliver services to the citizens and communities in Bedford Borough, it is necessary for the Council to collect, gather and process personal data about residents, staff and other individuals. Bedford Borough Council is committed to protecting your personal data when you use its services and/or correspond with it.

The Council has registered as a Data Controller with the Information Commissioner's Office. This registration can be viewed on the <a href="ICO website">ICO website</a> (opens in a new window) Registration Number Z5916725.

As a Data Controller, the Council sets out the purposes and methods for processing information and ensures safeguards over any personal and special category information it processes.

The sections below explain the arrangements we have in place to protect the information entrusted to the Council.

In relation to the administration and payment of Housing Benefit including the recovery of overpayments, Bedford Borough Council will process your personal data for the following processing purposes:

The administration and payment of Housing Benefit including the recovery of overpayments.

It is processing this personal data by virtue of the following Lawful Basis: **Compliance with a legal obligation.** 

Personal data provided for the administration and payment of Housing Benefit including the recovery of overpayments may be shared with, or obtained from the following organisations (in addition to any other disclosure required by a Court of Law or in response to a valid request by, normally, a law enforcement agency:

- Companies or other organisations appointed to carry out services on behalf of the Council in connection with the administration and payment of Housing Benefit and recovery of overpayments (for example, enforcement agents, solicitors, software providers, printers, entitlement review services, auditors);
- The County and other Courts;
- Government Departments (e.g. the Department for Work and Pensions, HMRC, Cabinet Office);
- The Valuation Office Agency;
- The Tribunal Service;
- The Police
- Employers (of persons required to repay an overpayment);
- Obtained from any other legal person (e.g. other local authorities, letting agents, solicitors, landlords, educational establishments, etc.).

The processing of your personal data will be restricted in time to: Six years prior to last the year in which there was last communication in respect of a Housing Benefit claim.

Your personal data will be held by/for the Council within the UK or the EU.

The information you have provided is a statutory or contractual requirement: this is something we have to do. Please see details below, including any consequences if we do not receive the information:

The provision of personal data is a statutory requirement to determine entitlement to Housing Benefit. A failure to provide such data may be a criminal or other form of offence and may result in incorrect assessment of entitlement.

We have a range of measures to protect the personal data you provide. These include: cyber security; physical security of the Council's buildings and training on Data Protection for staff.
