

PUBLIC NOTICE

BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE NEW PARKING RESTRICTIONS IN STANLEY STREET AND HOWARD STREET, KEMPSTON

Reason for Proposal:

Bedford Borough Council has received a request from Ward Councillors for some new parking restrictions at the corner of Stanley Street and Howard Street, Kempston. The proposal below is aimed at helping to maintain visibility and safety at this corner.

Effect of the Order:

1. To introduce 'No waiting at any time' restrictions (double yellow lines) on the following lengths of roads:

| Α | Stanley Street, Kempston |
|-------|-----------------------------------------------------------------------------|
| (i) | On its north-eastern kerb, extending from the north-western side of Howard |
| 17.00 | Street for a distance of approx. 10 metres in a north-westerly direction. |
| В | Howard Street, Kempston |
| (i) | On its north-western kerb, extending from the north-eastern side of Stanley |
| | Street for a distance of approx. 10 metres in a north-easterly direction. |

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 (Amendment No.26) Order 2024" and shall come into force on 2nd September 2024.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended shall be varied as follows:
 - (i) The plan schedule reference "Grid Ref: Kemp H 35 Revision No: 2" shall be deleted and the plan schedule reference "Grid Ref: Kemp H 35 Revision No: 3" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended.






