

#### **PUBLIC NOTICE**

### BEDFORD BOROUGH COUNCIL PROPOSE TO AMEND SOME PARKING RESTRICTIONS IN IDDESLEIGH ROAD, BEDFORD

#### Reason for Proposals:

Bedford Borough Council propose to revoke and amend some parking restrictions, revise parking bays, and introduce some "loading only" bays in Iddesleigh Road, Bedford, to improve residential parking and assist business premises with the loading and unloading of goods.

#### Effect of the Order:

1. To revoke existing single yellow line restrictions (No waiting Mon – Sat, 8am – 6.30pm) and to mark unlimited parking in its place on the following lengths of road:

Α	Iddesleigh Road, Bedford
(i)	On its northern kerb, extending from a point approx. 11 metres west of the
(.)	western side of Howard Place for a distance of approx. 60.5 metres in a westerly direction.
(ii)	On its northern kerb, extending from a point approx. 13.5 metres west of the centre of Hurst Grove for a distance of approx. 59.5 metres in a westerly direction.
(iii)	On its northern kerb, extending from a point approx. 80.3 metres west of the centre of Hurst Grove for a distance of approx. 25 metres in a westerly direction.
(iv)	On its northern kerb, extending from a point approx. 10 metres west of the centre of Coventry Road for a distance of approx. 38.5 metres in a westerly direction.

2. To revoke existing single yellow line restrictions (No waiting Mon - Sat, 8 am - 6.30 pm) and to introduce double yellow line restrictions (No waiting at any time) on the following lengths of road:

(i)	On its northern kerb, extending from a point approx. 12 metres east of the
	centre of Howard Place to a point approx. 13.5 metres west of the centre of
	Howard Place
(ii)	On its southern kerb, extending from a point approx. 18 metres east of the
	centre of Fairfax Road to a point approx. 9.5 metres west of the centre of
	Fairfax Road.
(iii)	On its southern kerb, extending from a point approx. 12 metres east of the
	centre of Cromwell Road to a point approx. 8 metres west of the centre of
	Cromwell Road.

3. To revoke a single yellow line restriction (No waiting Mon - Sat, 8 am - 6.30 pm) on the following lengths of roads:

### 4. To introduce a double yellow line restriction (No waiting at any time) on the following lengths of roads:

Α	Fairfax Road, Bedford
(i)	On both sides, from the southern side of Iddesleigh Road for a distance of
	approx. 5 metres in a southerly direction.
В	Howard Place, Bedford
(i)	On both sides, from the northern side of Iddesleigh Road for a distance of
	approx. 5 metres in a northerly direction.
С	Cromwell Road, Bedford
(i)	On both sides, from the southern side of Iddesleigh Road for a distance of
0.7 %	approx. 5 metres in a southerly direction.
D	Marlborough Road, Bedford
(i)	On both sides, from a point approx. 3.5 metres south of the southern side of
	Iddesleigh Road for a distance of approx. 1.5 metres in a southerly direction.

5. To revoke a time limited parking bay, Mon – Sat, 8am – 6pm, for a maximum period of 15 minutes, and to introduce "Loading Only 8am – 6.30pm 15 mins No return within 1 hour", in its place on the following length of road:

## 6. To revoke a time limited parking bay and introduce unlimited parking in its place on the following lengths of road:

Α	Iddesleigh Road, Bedford
(i)	On its southern kerb, extending from a point approx. 11 metres west of the western side of Hurst Grove to a point approx. 18 metres east of the centre of Fairfax Road.
(ii)	On its southern kerb, extending from a point approx. 9.5 metres west of the centre of Fairfax Road to a point approx. 12 metres east of the centre of Cromwell Road.
(iii)	On its southern kerb, extending from a point approx. 8 metres west of the centre of Cromwell Road for a distance of approx. 38.5 metres in a westerly direction.
(iv)	On its southern kerb, extending from a point approx. 7 metres west of the centre of Coventry Road to a point approx. 13 metres east of the centre of Marlborough Road.
(v)	On its southern kerb, extending from a point approx. 13 metres west of the

	centre of Marlborough Road for a distance of approx. 28.5 metres in a westerly direction.
(vi)	On its northern kerb, partially on the footway, extending from a point approx.
	13 metres west of the centre of Marlborough Road for a distance of approx.
	36 metres in a westerly direction.

7. To revoke a time limited parking bay and introduce "Loading Only 8am – 6.30pm 15 mins No return within 1 hour" on the following length of road:

Α	Iddesleigh Road, Bedford
(i)	On its southern kerb, extending from a point approx. 8.5 metres east of the
	centre of Coventry Road for a distance of approx. 15 metres in an easterly direction.

8. To revoke two "Electric vehicle recharging point only" bays at the following location and subject to the following restrictions:

Location:		
	of Westbourne Road for a distance of approx. 10 metres in ar	
	easterly direction.	
Restrictions:	: At all times: Only electric vehicles that are recharging will be	
	permitted to park in these bays.

	6 pm - 8 am: No time restrictions.	

9. To introduce two "Electric vehicle recharging point only" bays at the following location and subject to the following restrictions:

Road:	Road: Iddesleigh Road, Bedford	
Location:	On its southern kerb, extending from a point approx. 8 metres east of Westbourne Road for a distance of approx. 10 metres in an easterly direction.	
Restrictions:	At all times: Only electric vehicles that are recharging will be permitted to park in these bays.  8 am - 6 pm: Maximum stay 30 minutes, no return within 1 hour.  6 pm - 8 am: No time restrictions.

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.60) Order 2024" and shall come into force on 24<sup>th</sup> June 2024.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
  - (i) The plan schedule reference "Grid Ref: H 28 Revision No: 10" shall be deleted and the plan schedule reference "Grid Ref: H 28 Revision No: 11" shall be inserted.
  - (ii) The plan schedule reference "Grid Ref: H 29 Revision No: 6" shall be deleted and the plan schedule reference "Grid Ref: H 29 Revision No: 7" shall be inserted.
  - (iii) The plan schedule reference "Grid Ref: I 28 Revision No: 4" shall be deleted and the plan schedule reference "Grid Ref: I 28 Revision No: 5" shall be inserted.

3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.
