Reason for Proposal:

Bedford Borough Council has received a request from Ward Councillors for some new parking restrictions at the corner of King William Road and Riverview Way. This follows reports of inconsiderate parking by drivers. The proposal below is aimed at helping to maintain visibility and safety at this corner.

Effect of the Order:

1. To introduce "No waiting at any time" restrictions (double yellow lines) on the following length of road:

Α	King William Road, Kempston		
(i)	On its eastern kerb, extending from the projected boundary between		
	properties nos. 2 and 4 King William Road in a south-westerly direction to a		
	point approx. 12 metres south of its junction with Riverview Way.

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 (Amendment No.22) Order 2024" and shall come into force on 22nd July 2024.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended shall be varied as follows:
 - (i) The plan schedule reference "Grid Ref: Kemp E 37 Revision No: 0" shall be deleted and the plan schedule reference "Grid Ref: Kemp E 37 Revision No: 1" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended.


