

PUBLIC NOTICE

BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE NEW PARKING RESTRICTIONS IN MARGETTS ROAD AND OTHER ROADS, KEMPSTON

Reason for Proposals:

Bedford Borough Council has received a request from Ward Councillors for some new parking restrictions in Margetts Road, Kempston, at its junctions with Duncombe Street and Howard Street, together with an extension to existing double yellow lines. The proposal is aimed at helping to maintain visibility and safety at these locations.

Effect of the Order:

1. To revoke existing single yellow line restrictions (No waiting Mon – Sat, 7am – 7pm) and to introduce double yellow line restrictions (No waiting at any time) on the following length of road:

Α	Margetts Road, Kempston			
(i)	On its south-western kerb, extending from a point approx. 26 metres south			
	east of its junction with Bedford Road for a distance of approx. 12 metres in			
	south-easterly direction.			

2. To introduce a double yellow line restriction (No waiting at any time) on the following lengths of roads:

Α	Margetts Road, Kempston			
(i)	On its south-western kerb, extending from the south-eastern side of Cater Street for a distance of approx. 4 metres in a south-easterly direction.			
(ii)	On its south-western kerb, extending from the north-western side of Duncombe Street for a distance of approx. 4 metres in a north-western direction.			
(iii)	On its south-western kerb, extending from the south-eastern side of Duncombe Street for a distance of approx. 4 metres in a south-easterly direction.			
(iv)	On its south-western kerb, extending from the north-western side of Howard Street for a distance of approx. 4 metres in a north-westerly direction.			
(v)	On its south-western kerb, extending from the south-eastern side of Howard Street for a distance of approx. 4 metres in a south-easterly direction.			
В	Cater Street, Kempston			
(i)	On its south-eastern kerb, extending from the south-western side of Margetts Road for a distance of approx. 4 metres in a south-westerly direction.			
С	Duncombe Street, Kempston			
(i)	On both sides, extending from the southern side of Margetts Road for a distance of approx. 4 metres in a south-westerly direction.			
D	Howard Street, Kempston			
(i)	On both sides, extending from the southern side of Margetts Road for distance of approx. 4 metres in a south-westerly direction.

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 (Amendment No.25) Order 2024" and shall come into force on 14th October 2024.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended shall be varied as follows:
 - (i) The plan schedule reference "Grid Ref: Kemp H 34 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: Kemp H 34 Revision No: 2" shall be inserted.
 - (ii) The plan schedule reference "Grid Ref: Kemp H 35 Revision No: 3" shall be deleted and the plan schedule reference "Grid Ref: Kemp H 35 Revision No: 4" shall be inserted.
- This Amendment shall be read and construed as one with the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended.




