**BEDFORD BOROUGH COUNCIL (DEFINITIVE MAP AND STATEMENT FOR THE
FORMER NORTH BEDFORDSHIRE BOROUGH) (SHARNBROOK: FOOTPATH NO.13)
MODIFICATION ORDER 2021**

The above Order, made on 16 June 2021, if confirmed as made, will modify the definitive map and statement for the area by deleting from them that length of public footpath in the Parish of Sharnbrook numbered 13 in the Definitive Statement commencing from a point where it has a junction with that part of public Footpath number 13 Sharnbrook that is unaffected by this order approximately 19 metres north-east of number 18 Towns End Road, Sharnbrook at Ordnance Survey Grid Reference (OSGR) SP 9934/5978 shown as Point "A" on the order map then running in a generally south-south-easterly direction for 48 metres to a point where it terminates without having a junction with any other highway at OSGR SP 9935/5973 shown as Point "B" on the order map and adding to them a length of public footpath in the Parish of Sharnbrook commencing from a point where it has a junction with that part of public footpath number 13 that is unaffected by this order approximately 19 metres north-east of number 18 Towns End Road, Sharnbrook at Ordnance Survey Grid Reference (OSGR) SP 9934/5978 shown as Point "A" on the order map then running in a generally south-south-westerly direction for 24 metres to a point where it has a junction with that other part of public footpath number 13 Sharnbrook that is unaffected by this order at OSGR SP 9932/5976 shown as Point "C" on the order map.

Any representation or objection relating to the order must be sent in writing to the Bedford Borough Council, Manager for Traffic Operations, Room 436, Borough Hall, Cauldwell Street, Bedford MK42 9AP or by email to highways.consultations@bedford.gov.uk not later than Friday 24 September 2021, and applicants are requested to state the grounds on which it is made.

If no representations or objections are duly made to the order, or if any so made are withdrawn the Bedford Borough Council, instead of submitting the order to the Secretary of State may itself confirm the Order. If the Order is submitted to the Secretary of State for the Environment, Food and Rural Affairs, any representations and objections which have not been withdrawn will be sent with it.
