This dropped to 37% when asked about the evening'. During the day only 5% answered that they felt 'unsafe' or 'very unsafe'. This increased to 33% in the evening. When asked 'how safe do you feel in your local area', 91% of respondents to the survey said they felt safe or very safe during the day, against 3% feeling unsafe or very unsafe. 63% said they felt safe or very safe 'after dark', with 21% saying they felt unsafe or very unsafe.

This figure drops noticeably after dark however, particularly in the town centre. More people report feeling unsafe after dark both in the town centre and in their local area, than during the day, when only small percentages say they felt unsafe.
