

#### **PUBLIC NOTICE**

### BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE NEW PARKING RESTRICTIONS ALONG PEMBERLEY AVENUE, BEDFORD

#### Reason for Proposal:

As part of a Section 278 Agreement in connection with the construction of a new school, Bedford Borough Council proposes to remove existing School Keep Clear markings and introduce new parking restrictions along Pemberley Avenue, Bedford.

#### Effect of the Order:

1. To introduce 'No waiting at any time' restrictions (double yellow lines) on the following lengths of road:

Α	Pemberley Avenue, Bedford	
(i)	i) On its southern kerb, from a point approx. 14.5 metres west of the project	
	centre line of St Andrews Road for a distance of approx. 13 metres in a	
	south-westerly direction.	
(ii)	On its south-eastern kerb, from a point approx. 44.5 metres south-west	
	the projected centre line of St Andrews Road for a distance of approx. 17.5	
	metres in a south-westerly direction.	

2. To revoke existing "No stopping on entrance markings" restrictions on the following length of road:

Α	Pemberley Avenue, Bedford				
(i)	On its southern kerb, extending from a point approx. 57 metres west of				
	Kimbolton Road for a distance of approx. 63 metres in a westerly direction.

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.100) Order 2024" and shall come into force on 12<sup>th</sup> August 2024.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
  - (i) The plan schedule reference "Grid Ref: K 24 Revision No: 3" shall be deleted and the plan schedule reference "Grid Ref: K 24 Revision No: 4" shall be inserted.
- his Amendment shall be read and construed as one with the Bedford Borough Council (North of the River Excluding Queens Park and CPZ Areas))
   (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.




