

PUBLIC NOTICE

BEDFORD BOROUGH COUNCIL PROPOSES TO INTRODUCE A 20MPH ZONE ON ROADS IN GREAT DENHAM

Reason for Proposal:

Great Denham Parish Council have requested that the speed limit be reduced to 20mph throughout Great Denham, following complaints from residents about speeding through the village.

The proposed 20mph Zone is intended to provide a safer road network for all highway users, including motor cyclists, pedal cyclists and pedestrians.

Effect of the Order:

1. To introduce a 20mph Zone covering the entire length of each of the following roads in Great Denham:-
