This Order is made by Bedford Borough Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the authority that the Definitive Map and Statement for The Former North Bedfordshire Borough require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) of the Act namely:-

- 3(c) the discovery by the surveying authority of evidence which (when considered with all other relevant evidence available to them) shows:
- (i) that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic

The authority has consulted with every local authority whose area includes the land to which the order relates. The Bedford Borough Council hereby order that:

- 1. For the purposes of this order the relevant date is 30 June 2022.
- 2. The Definitive Map and Statement for The Former North Bedfordshire Borough shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
