

# BEDFORD BOROUGH COUNCIL (THE PARISH OF CARLTON, BEDFORD) (PROHIBITION OF WAITING) ORDER 2018 (AMENDMENT NO.1) ORDER 2022

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (The Parish of Carlton, Bedford) (Prohibition of Waiting) Order 2018 (Amendment No.1) Order 2022" and shall come into force on 4<sup>th</sup> April 2022.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (The Parish of Carlton, Bedford) (Prohibition of Waiting) Order 2018 as amended shall be varied as follows:
  - (i) The following entries shall be inserted into the Schedule to the Order:

F	Street Close		
(i)	On both sides of the road, extending from High Street for a distance of		
1	approx. 10 metres in a generally north-easterly direction.		
G	High Street		
(i)	On its eastern kerb, extending from the centre of Street Close for a		
	distance of approx. 16 metres in a generally north-westerly direction.		
(ii)	On its eastern kerb, extending from the centre of Street Close for a		
	distance of approx. 17 metres in a generally south-easterly direction.		

3. This Amendment shall be read and construed as one with the Bedford Borough Council (The Parish of Carlton, Bedford) (Prohibition of Waiting) Order 2018 as amended.



### **STATEMENT OF REASONS**

Bedford Borough Council has received a request from Carlton and Chellington Parish Council for some parking restrictions at the junction of Street Close/High Street, Carlton. This is in response to inconsiderate parking at the junction which affects visibility and safety, so the proposed restrictions are intended to keep the corners clear of parked vehicles.



= Proposed Double Yellow Lines

- 1. Double yellow lines to Diagram 1018.1 of the TSRGD 2016 must be minimum-width and in primrose yellow because this is in a conservation area.
- 2. Erase existing white edge line in High Street where replaced by new double yellow lines.
- Double yellow lines at the start of Street Close extend for a distance of 10 metres from the perpendicular of the junction.
