## (BEDFORD URBAN AREA (SOUTH OF THE RIVER AND QUEENS PARK)) (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) ORDER 2009 (AMENDMENT NO.45) ORDER 2022

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.45) Order 2022" and shall come into force on 18<sup>th</sup> March 2022.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
  - (i) The plan schedule reference "Grid Ref: K 31 Revision No: 3" shall be deleted and the plan schedule reference "Grid Ref: K 31 Revision No: 4" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.




### STATEMENT OF REASONS

Bedford Borough Council have received a request from Ward Councillors for some parking restrictions in St Leonards Street, Bedford. The request is in response to concerns raised about inconsiderate parking on some corners of the road which affects the ability of other vehicles to safely travel along the carriageway. This proposal is aimed at keeping those corners free of parked vehicles so as to help maintain safe passage for all highway users.
