# Guidance

## **Document purpose**

This guidance and template aims to assist applicants or their agents in producing or commissioning the necessary heritage statement and impact assessment when submitting a listed building application or planning application for simple changes affecting a single heritage asset.

\*For more complex proposals (e.g. those that may have multiple effects on one or more heritage assets) requiring the services/input of historic environment specialists, please refer to and refer them to the <u>Heritage Statement of Significance and Impact</u> <u>Assessment Brief'.</u>

There is no requirement to use the template provided at the end of this document, however the issues covered need to be included within the submission in order for the application to be validated.

## Requirements

A Heritage Statement and Impact Assessment must be submitted with any application for Listed Building Consent or Planning Permission affecting designated heritage assets and their settings including, listed buildings, scheduled monuments, registered parks and gardens, registered battlefields, conservation areas, or non-designated heritage assets where a statement and assessment has been specifically requested by the LPA. This is to accord with paragraph 194 of the NPPF and policy 41s of the Bedford Borough Local Plan 2030.

## **Validation Process**

Listed building and planning applications will not be validated or processed unless the required Heritage Statement and Impact Assessment has been submitted. If post validation and upon further scrutiny, the statement is found wanting in a particular area or areas, the LPA will request further information and if this is not forthcoming, the application may be refused upon the grounds of insufficient information. This may also include occasions where an archaeological desk based assessment and/or archaeological evaluation is required prior to the determination of a planning application and the results have not been submitted with the application.

# The Bedford Borough Historic Environment Record (BBHER)

The BBHER is a chargeable service and contains details on local archaeological sites and finds, historic buildings and landscapes. Entries on the BBHER can be a primary source of information for planning and listed building consent applications. In some, more minor applications however, where the detail of a heritage statement does not need to be exhaustive; the above sources of information may be sufficient without consulting the BBHER.

To check what information is contained on the BBHER, you can use the Heritage Gateway website, which provides a list of documents on each file. Please note that the Heritage Gateway website will not contain the information itself, and a search on the Heritage Gateway website does not constitute a full search of the HER.






