PUBLIC PATH CREATION ORDER 2021**

This Order is made by the Bedford Borough Council ("the Authority") under Section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that, having regard to the matters set out in Section 26(1), there is a need for a public Bridleway over the land to which this Order relates, and that it is expedient that the Bridleway should be created.


BY THIS ORDER:

1. There shall be at the expiration of 14 (fourteen) days from the date of confirmation of this Order be a public Bridleway over the way known as "Old Milton Road, Thurleigh" between the Bedford Borough Highway, Old Milton Road, Thurleigh (Road UC 31) and Bridleway number 7 Milton Ernest in the parish of Milton Ernest described in the Schedule to this Order and shown by a bold broken with cross bars line between points A to B on the map attached to this Order.
2. This Order may be cited as the "Bedford Borough Council (Milton Ernest: Bridleway from Old Milton Road (UC 31) to Milton Ernest Bridleway No. 7) Public Path Creation Order 2021".

SCHEDULE

DESCRIPTION OF LAND

A length of Public Bridleway in the Parish of Milton Ernest that commences at a point where it has a junction with the publicly maintained part of "Old Milton Road", Thurleigh (Road UC 31) at the parish boundary between Milton Ernest and Thurleigh at Ordnance Survey Grid Reference (OSGR) TL 0374/5707 shown as Point A on the map attached to this order then running in a generally south-westerly direction for approximately 333 metres to a point where it has a junction with Public Bridleway number 7 Milton Ernest at OSGR TL 0348/5687 shown as Point B on the map attached to this order.

The new length of Public Bridleway described above shall have a width of 4 (four metres) throughout.

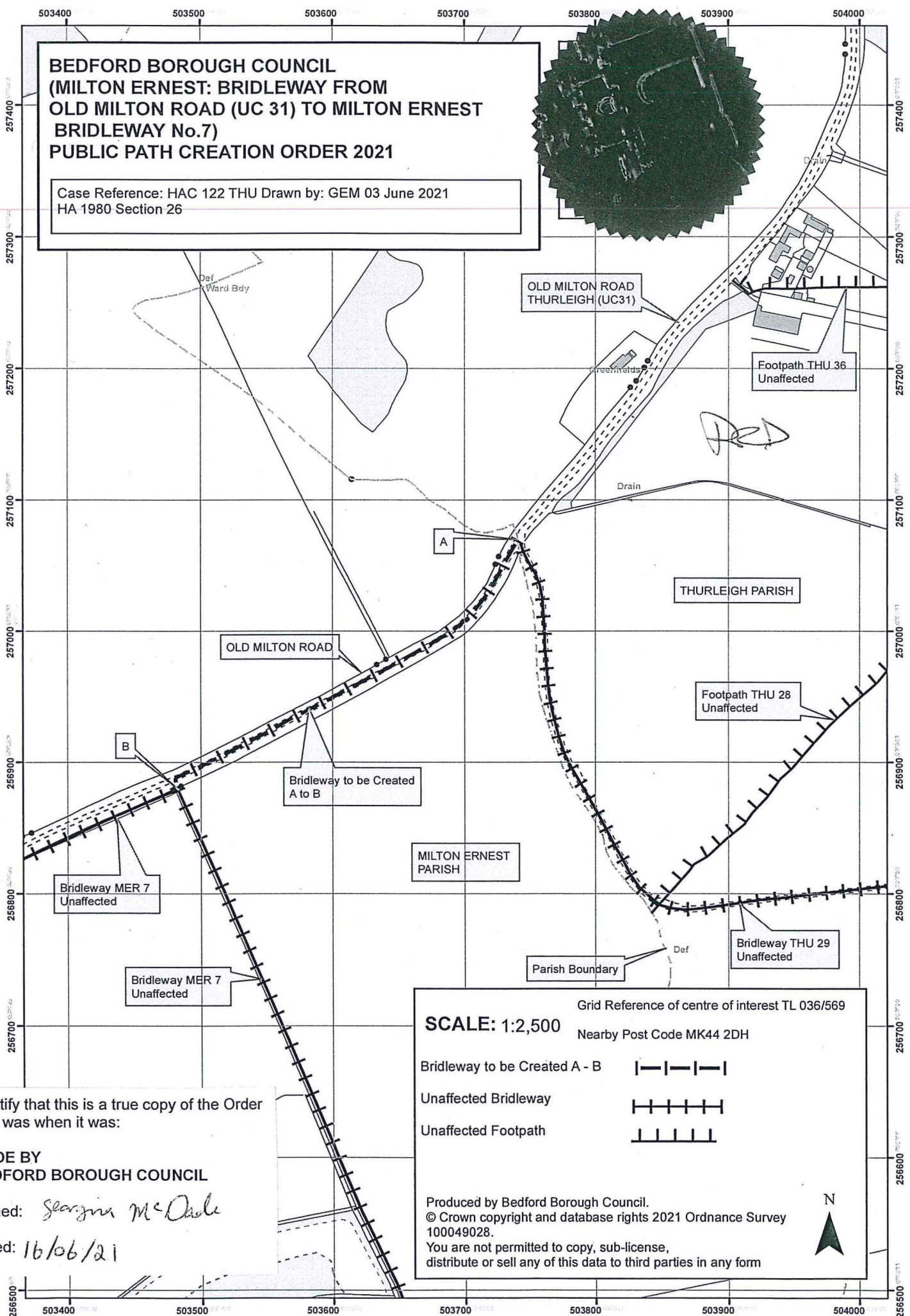
