### Samantha Laycock - Town Deal Chair of Board



Born and bred in Bedford, Samantha's career began in retail holding various positions as a Store Manager over ten years. In June 2007, Samantha joined the management team at the Harpur Centre in Bedford which consists of 35 retail outlets and after graduating in 2010, Samantha became the Centre Manager and also held the voluntary position of Director on the BID until she became Chair in 2016 to present day.

She is a member of the British Council of Shopping Centres (Revo) and holds various industry qualifications including IOSH, First Aid and the Diploma of Shopping Centre Management. Samantha was then voted Chair of the Town Board Deal due to her passion, experience and excellent stakeholder relationships within the town.

### Dave Hodgson - Vice Chair of Board



Dave Hodgson MBE is the Elected Mayor and leader of Bedford Borough Council. He is a Liberal Democrat, and was first elected Mayor in October 2009 and re-elected in May 2019, 2015 and 2011.

As Mayor, he represents Bedford Borough on a local, regional and national basis, appoints Councillors to his Executive, and is responsible for the majority of Council services while specifically holding the portfolio for economic development amongst others. Dave has made the economic growth of the Bedford borough one of his key targets and priorities since being elected.

Kevin Bolt MCIM – CEO, bpha



Kevin has been CEO of bpha, Bedford's principal housing association with more than 10,000 homes in the area, since May 2014. He came into housing via a career in consumer goods and change management Consultancy. He has a depth and breadth of commercial experience gained working at Board level in the private and public sectors. His first experience of the Housing Sector came in 2012 when he undertook a consultancy project with bpha and he has been a passionate advocate for the volume and quality of affordable housing in Bedford ever since.

Hilary Chipping - CEO, South East Midlands Local Enterprise Partnership (SEMLEP)



Hilary is Chief Executive at the South East Midlands Local Enterprise Partnership (SEMLEP), which she helped to establish in 2011. She leads on setting the strategic economic priorities for the South East Midlands area, including overseeing a £265m programme of capital investment through the Local Growth Fund. During her tenure, SEMLEP has published the Local Industrial Strategy and Strategic Economic Plan for the area, Skills Plan and Energy Strategy. Hilary works closely with central Government, local authority, regional and private sector partners and the national network of Local Enterprise Partnerships to enable the delivery of infrastructure to unlock economic and housing growth, develop skills and create good quality places.

From 2008 to 2011, Hilary was Director of the Milton Keynes South Midlands Growth Area (the largest growth area in the UK).

As Director of Network Strategy at the Highways Agency from 2001 to 2007 she developed the investment strategy for the motorway and trunk road network.

Hilary graduated from the University of Manchester with an MA in economics and joined the Department of the Environment as an economist working initially on housing and then, from 1984, local government finance.

## Juliet Fern - Interim Executive Dean, Faculty of Education and Sport, University of Bedfordshire

He was Portfolio Holder on the council for Adult Services and held the roles of Deputy Speaker and Speaker of the Council.

Yasin is a proud resident of Bedford, committed to representing his constituents in Westminster to increase the resilience and progress of the towns of Bedford and Kempston. In 2019, he pledged to bring mental health beds back to Bedford Hospital, increase police funding and protect local services. In Westminster, Yasin pushes for economically sound and just policies to bring about a fairer society and is committed to combatting climate change through low emissions, sustainable energy and a green Covid-19 recovery.
