BEDFORD BOROUGH COUNCIL (DEFINITIVE MAP AND STATEMENT FOR THE FORMER NORTH BEDFORDSHIRE BOROUGH) (ODELL: BYWAY OPEN TO ALL TRAFFIC No. 42) MODIFICATION ORDER 2022

This Order is made by the Bedford Borough Council under Section 53(2)(b) of The Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement for The Former North Bedfordshire Borough require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) of the Act namely:-

- (c) the discovery by the surveying authority of evidence which (when considered with all other relevant evidence available to them) shows:
- (i) that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic

The authority has consulted with every local authority whose area includes the land to which the Order relates. The Bedford Borough Council order that:

1. For the purposes of this Order the relevant date is 30 June 2022.
2. The Definitive Map and Statement for The Former North Bedfordshire Borough shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Bedford Borough Council (Definitive Map and Statement for The Former North Bedfordshire Borough) (Odell: Byway Open to All Traffic No. 42) Modification Order 2022".

Modification of Definitive Map

Description of Path or Way to be Added

A Byway Open to All Traffic in the Parish of Odell to be numbered 42 in the Definitive Statement commencing from a point where it has a junction with the northernmost extent of the Borough Highway "Church Lane" which is shown on the List of Streets as a highway maintainable at public expense approximately 55 metres south west of Byway Open to All Traffic No. 4 Odell at Ordnance Survey Grid Reference (OSGR) SP 9677/5918 shown as Point "A" on the Order Map then running in a generally north-eastern direction for 55 metres to a point where it joins with Byway Open to All Traffic No. 4 Odell at OSGR SP 9679/5922 shown as Point "B" on the Order Map.

The Byway Open to All Traffic described above shall have a width of 3 metres throughout.

The way is a Byway Open to All Traffic (BOAT).

It starts at Ordnance Survey Grid Reference (OSGR) SP 9677/5918 where it has a junction with that part of Church Lane which is shown on the List of Streets as a highway maintainable at public expense then running in a generally north-eastern direction for 55 metres to a point where it has a junction with Byway Open to All Traffic No. 4 Odell at OSGR SP 9679/5922.

BOAT Number 42 Odell has a width of 3 metres throughout.

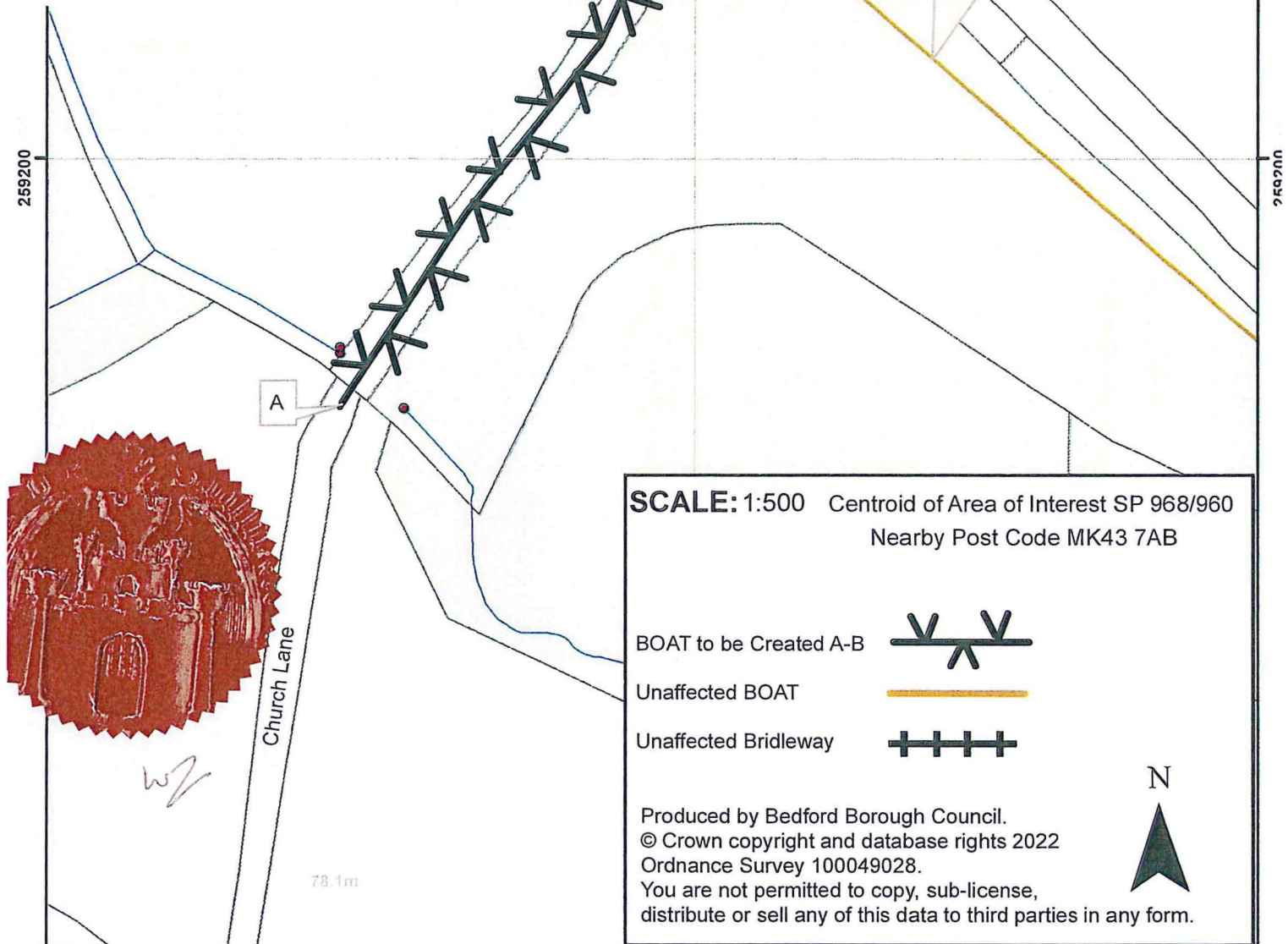
