This Order is made by Bedford Borough Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the authority that the Definitive Map and Statement for The Former North Bedfordshire Borough require modification in consequence of the occurrence of an event specified in section 53(3)(c)(iii) of the Act namely:-

- (c) the discovery by the surveying authority of evidence which (when considered with all other relevant evidence available to them) shows:
- (iii) that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Bedford Borough Council hereby order that:


1. For the purposes of this Order the relevant date is 01 March 2021.

DESCRIPTION: The path is a F.P. (Awarded).

This right of way is an Awarded Footpath shown in the Inclosure Award for Kempston dated 1804 where the path is recorded as being 4 feet wide throughout.

It starts at Green End. Gap by field gate, the F.P. approx. 2 ft. wide exists appearing to belong to garden of private house and it is doubtful if this is used at all by the general public. There is an old stile at the back boundary fence but this has been obstructed (by an old bed rail). From this point there is only very slight evidence that a F.P. has existed. It follows hedge on its west side until F.P. joins F.P. A8 and then turns westerly with hedge now on south side. The F.P. continues becoming very marshy in places until it connects with Gipsy Lane.
