(AMENDMENT NO.80) ORDER 2022

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.80) Order 2022" and shall come into force on 1st January 2023.
2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
 - (i) The plan schedule reference "Grid Ref: M 23 Revision No: 7" shall be deleted and the plan schedule reference "Grid Ref: M 23 Revision No: 8" shall be inserted.
 - (ii) The plan schedule reference "Grid Ref: K 23 Revision No: 2" shall be deleted and the plan schedule reference "Grid Ref: K 23 Revision No: 3" shall be inserted.
 - (iii) The plan schedule reference "Grid Ref: L 23 Revision No: 6" shall be deleted and the plan schedule reference "Grid Ref: L 23 Revision No: 7" shall be inserted.
3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.
