**BEDFORD BOROUGH COUNCIL (BEDFORD: PART OF FOOTPATH No. 1)
PUBLIC PATH DIVERSION ORDER 2023**

THIS ORDER is made by the Bedford Borough Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owners of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the footpath should be diverted.

BY THIS ORDER

1. The public rights of way over the land situated in the environs of Goldington Academy, Bedford and shown by a bold continuous line between Points A – B on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 7 (seven) days from the date of confirmation of this Order.
2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the same rights over the land referred to in paragraph 1 above, in respect of their apparatus under, in, upon, over, along or across the said land as they had immediately before the date of confirmation of this Order.
3. There shall be at the end of 7 (seven) days from the date of confirmation of this Order a public footpath over the land situated west of Poplar Tree Court, Bedford as described in Part 2 of the Schedule to this Order and shown by a bold broken line between Points A - C on the map attached to this Order.
4. This Order may be cited as the "Bedford Borough Council (Bedford: Part of Footpath No. 1) Public Path Diversion Order 2023".

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That length of Public Footpath numbered 1, Bedford commencing from the unaffected part of Footpath 1 Bedford approximately 26 metres west-south-west of 108, Brookfield Road, Bedford at Ordnance Survey Grid Reference (OSGR) TL 0678/5077 shown as Point A on the attached map then running in a north-west direction for approximately 237 metres to a point where it has a junction with that part of the unaffected Public Footpath number 1 to be retained at OSGR TL 0655/5085 shown as Point B on the Order Map.

The Definitive Statement records no width for the said Public Footpath. For the avoidance of doubt, it is intended for this Order to stop up the length of Public Footpath described above in its entirety.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A length of Public Footpath to be created by this Order approximately 26 metres west-south-west of 108, Brookfield Road, Bedford commencing from a point where it has a junction with that part of Public Footpath number 1 to be retained at Ordnance Survey Grid Reference (OSGR) TL 0678/5077 shown as Point A on the attached map then running in a generally south west direction for approximately 286 metres to Ordnance Survey Grid Reference OSGR TL 0656/5059, where it has a junction with the public road known as "Polhill Avenue" shown as Point C on the Order map.

The new length of Public Footpath described above shall have a width of 2.0 (two) metres throughout.
