

BEDFORD BOROUGH COUNCIL PROPOSE TO MAKE AMENDMENTS TO THE BUS LANE ON AMPTHILL ROAD, BEDFORD

Reason for Proposal:

Taxis and private hire vehicles were previously permitted to use all of the bus lane on Ampthill Road, Bedford. However, as Ultra Low Emission Vehicles (ULEVs) are now permitted to use the bus lane, and to continue to promote greener travel, it is felt that the exemption that allowed the blanket use of the bus lane by any taxis and private hire vehicles should be revoked.

This means that all taxis and private hire vehicles, in line with other vehicles, would now only be permitted to use the bus lane if they were ULEVs.

A ULEV is defined as a vehicle with CO2 tailpipe emissions of less than 75 grams per kilometre and with a capability of travelling a minimum range of 10 miles with zero CO2 emissions.

Effect of the Order:

1. To permit any Ultra Low Emission Vehicles (ULEVs) to use the existing bus lane:-

Α	Ampthill Road, Bedford
(i)	On its northbound carriageway, from a point approx. 7 metres north of the
	centre of Sexton Avenue to a point approx. 6 metres south of the centre of the
	hospital access road.

2. To revoke permission for taxis and private hire vehicles to use any part of the bus lane on Ampthill Road, Bedford unless they are ULEVs.

BEDFORD BOROUGH COUNCIL (BUS LANES AND BUS ONLY STREETS, THE BOROUGH OF BEDFORD) CONSOLIDATION ORDER 2014 (AMENDMENT NO.*) ORDER 20**

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1), 2(2) and 4 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. This Order may be cited as the "Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014 (Amendment No.*) Order 20**" and shall come into force on ** **** 20**.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014 as amended shall be varied as follows:
 - (i) The following paragraph shall be deleted from Article 3 of the Order ("Interpretation and Definitions"):
 - "Ultra Low Emission Vehicle" means a vehicle with CO2 tailpipe emissions of less than 75 grams per kilometre and with a capability of traveling a minimum range of 10 miles with zero CO2 emissions.
 - (ii) The following paragraph shall be added to Article 3 of the Order ("Interpretation and Definitions"):
 - "Ultra Low Emission Vehicle" means a vehicle with CO2 tailpipe emissions of less than 75 grams per kilometre and with a capability of travelling a minimum range of 10 miles with zero CO2 emissions
 - (iii) The existing "Schedule 1 Identification of streets forming a Bus Lane" shall be deleted and the "Schedule 1 Identification of streets forming a Bus Lane" specified in the Schedule to this Order shall be inserted in its place.
 - (iv) The plan schedule reference "Grid Ref: I 35 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: I 35 Revision No: 2" shall be inserted.

- (v) The plan schedule reference "Grid Ref: I 36 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: I 36 Revision No: 2" shall be inserted.
- (vi) The plan schedule reference "Grid Ref: J 31 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: J 31 Revision No: 2" shall be inserted.
- (vii) The plan schedule reference "Grid Ref: J 32 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: J 32 Revision No: 2" shall be inserted.
- (viii) The plan schedule reference "Grid Ref: J 33 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: J 33 Revision No: 2" shall be inserted.
- (ix) The plan schedule reference "Grid Ref: J 34 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: J 34 Revision No: 2" shall be inserted.
- (x) The plan schedule reference "Grid Ref: J 35 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: J 35 Revision No: 2" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014 as amended.

STATEMENT OF REASONS
