unoccupied and might still contain the deceased's identity theft. Taking in to account the above issues, the council considers that there is no over-riding public interest in releasing the information requested. Any public interest would be best service by upholding the exemption under Section 31 of the Act as disclosure of the information would be likely to prejudice the prevention of crime by enabling or encouraging the commission of offence.
