

PUBLIC NOTICE

BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE NEW PARKING RESTRICTIONS IN BROMHAM ROAD, BEDFORD

Reason for Proposal:

Bedford Borough Council has received a request from Ward Councillors for new parking restrictions at the Bromham Road junction with Cutcliffe Grove, Bedford. This is in response to concerns raised over inconsiderate parking at this location which affects visibility and safety, so these restrictions are intended to remedy that.

Effect of the Proposal:

1. To introduce 'No waiting at any time' restriction (double yellow lines) on the following lengths of road:-

Α	Bromham Road, Bedford
(i)	On its southern kerb, from a point approx. 6 metres west of the projected south-western side of Cutcliffe Grove (the end of the existing 'No waiting at any time' restriction) extending for a distance of approx. 10 metres in a westerly direction.
(ii)	On its southern kerb, from a point approx. 7 metres east of the projected north-eastern side of Cutcliffe Grove (the end of the existing 'No waiting at any time' restriction) extending for a distance of approx. 10 metres in an easterly direction.

Relevant proposal documents may be examined during normal office hours at Borough Hall, Cauldwell Street, Bedford, MK42 9AP. They will also be available for viewing on the council's website at www.bedford.gov.uk/proposedtro. The documents will be placed on deposit until 6 weeks after the Order is made or until it is decided not to continue with the proposal. BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.59) Order 2023" and shall come into force on 4th December 2023.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
 - (i) The plan schedule reference "Grid Ref: H 26 Revision No: 7" shall be deleted and the plan schedule reference "Grid Ref: H 26 Revision No: 8" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (South of the River and Queens Park)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.




