### BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE NEW PARKING RESTRICTIONS IN CLEVELAND STREET AND DUNCOMBE STREET, KEMPSTON

#### Reason for Proposal:

Bedford Borough Council has received a request from Ward Councillors for some new parking restrictions at the corner of Cleveland Street and Duncombe Street. This follows reports of inconsiderate parking by drivers. The proposal below is aimed at helping to maintain visibility and safety at this corner.

#### **Effect of the Order:**

1. To introduce "No waiting at any time" restrictions (double yellow lines) on the following lengths of road:

Α	Cleveland Street, Kempston		
(i)	On its north-eastern kerb, from a point approx. 50 metres south-east of the		
	south-east side of Cater Street to its junction with Duncombe Street.		
В	Duncombe Street, Kempston		
(i)	On its north-western kerb, from its junction with Cleveland Street extending to a point approx. 6 metres north-east of the south-western boundary of no. 1 Cleveland Street.

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 (Amendment No.20) Order 2023" and shall come into force on 21<sup>st</sup> August 2023.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended shall be varied as follows:
  - (i) The plan schedule reference "Grid Ref: Kemp G 35 Revision No: 1" shall be deleted and the plan schedule reference "Grid Ref: Kemp G 35 Revision No: 2" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Kempston) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2018 as amended.




