

## **Transfer to Secondary School (Year 7) – September 2024**

The table below lists the number of requests for places for the Year 7 intake at each of the secondary schools/academies and the number of places that have been offered in accordance with the published admissions arrangements **on National Offer Day, 1st March 2024**. The information will give you an indication of the level of oversubscription, which you may find helpful if we have been unable to offer you a place at your preferred school(s), because your application was not high enough on the list for admission.

\* Where a child living within the administrative area of Bedford Borough Council has been unable to secure a school place through the normal transfer process, and they are not attending a school where they can remain in September, the Local Authority has a duty to nominate the next nearest school with places available.

### **Appeals**

If your application has been unsuccessful, you have the right to appeal against this decision.

**If you have been unsuccessful in gaining a place at a school in another local authority and you wish to appeal, you should contact the relevant council for more information.**

## **Waiting Lists**

If your child has not been offered a place at your preferred school(s), they will be placed on the waiting list which has been prioritised in accordance with the admissions criteria for individual schools. If a place becomes available the relevant local authority will contact you, even if you have accepted a place at an alternative school/academy. The waiting lists will be maintained until the end of the Autumn term 2024 (31 December 2024). If you wish to remain on the waiting list beyond that time, you will need to contact the School Admissions Service of the relevant local authority.
