

PUBLIC NOTICE

BEDFORD BOROUGH COUNCIL PROPOSE TO INTRODUCE NEW PARKING RESTRICTIONS IN HINDBURN CLOSE AND DOUGLAS ROAD, BEDFORD

Reason for Proposal:

Bedford Borough Council has received a request from Ward councillors for new parking restrictions at the junction of Hindburn Close with Douglas Road, Bedford. This is in response to concerns raised over inconsiderate parking at this location which affects visibility and safety, so these restrictions are intended to remedy that.

Effect of the Order:

1. To introduce "No waiting at any time" restrictions (double yellow lines) on the following lengths of roads:

Α	Douglas Road, Bedford	
(i)	On its northern kerb, extending from the centre of Hindburn Close for a	
2 .50	distance of approx. 14 metres in both a south-westerly direction and easterly	
	direction.	
В	Hindburn Close, Bedford	
(i)	On both sides of the road, from the north side of Douglas Road extending for	
	a distance of approx. 10 metres in a north-westerly direction.

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3) and 4(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the "Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 (Amendment No.104) Order 2024" and shall come into force on 28th May 2024.
- 2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended shall be varied as follows:
 - (i) The new plan schedule reference "Grid Ref: L 15 Revision No: 0" shall be inserted.
- 3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bedford Urban Area (North of the River Excluding Queens Park and CPZ Areas)) (Prohibition and Restriction of Waiting and Loading and Parking Places) Order 2009 as amended.


