**CONSOLIDATION ORDER 2014 (AMENDMENT NO.3) ORDER 2021**

BEDFORD BOROUGH COUNCIL ("the Council") in exercise of the powers conferred by Sections 1(1), 2(1), 2(2) and 4 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the Act") and of all other powers enabling them in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as the "Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014 (Amendment No.3) Order 2021" and shall come into force on 3<sup>rd</sup> September 2021.
2. As from the date upon which this Order comes into force the provisions of the Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014 as amended shall be varied as follows:
  - (i) The existing "Schedule 2 – Identification of streets forming a Bus Only Street" shall be deleted and the "Schedule 2 – Identification of streets forming a Bus Only Street" specified in the Schedule to this Order shall be inserted.
  - (ii) The plan schedule reference "Grid Ref: E 41 Revision No: 0" shall be inserted.
3. This Amendment shall be read and construed as one with the Bedford Borough Council (Bus Lanes and Bus Only Streets, The Borough of Bedford) Consolidation Order 2014 as amended.

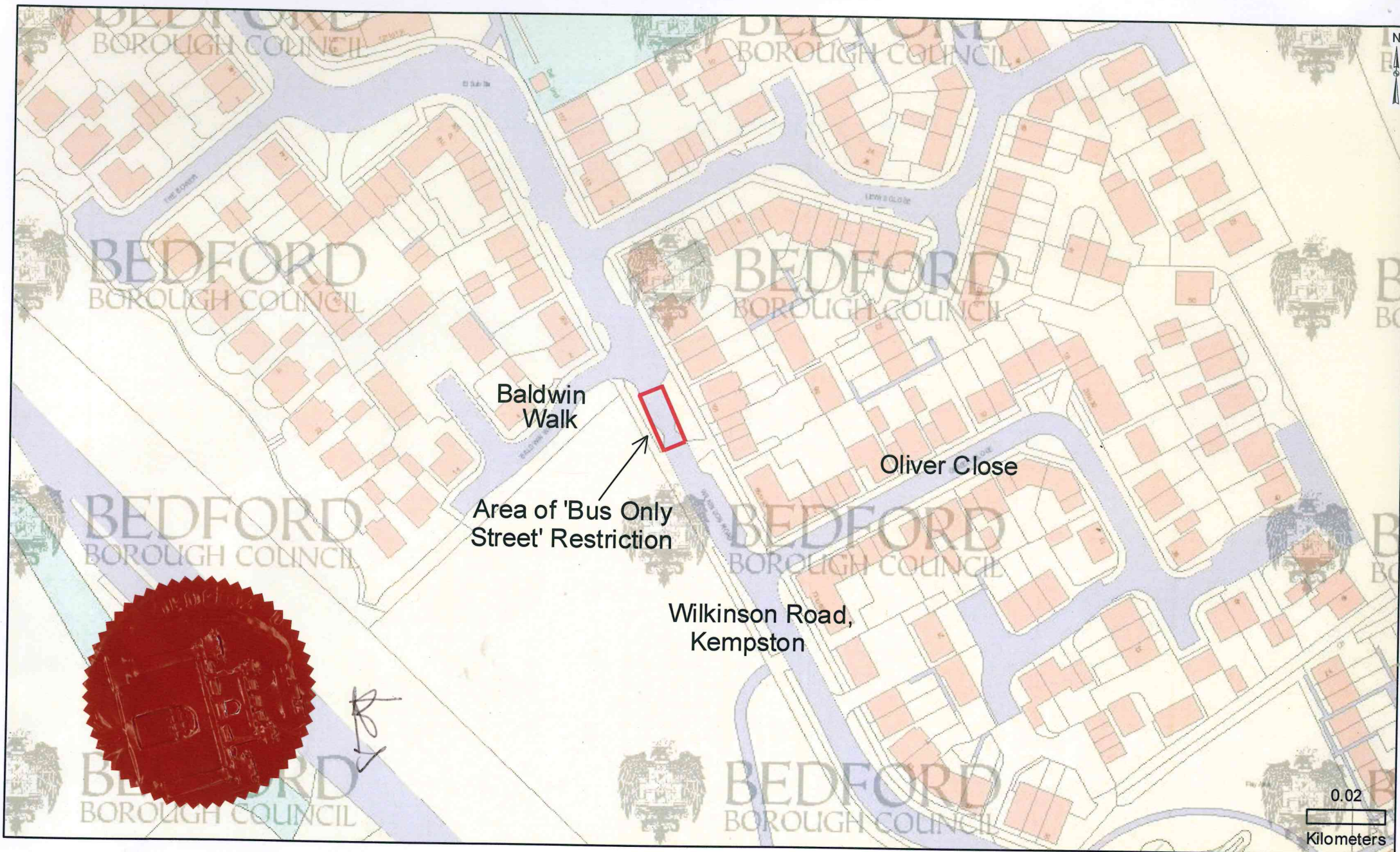
**STATEMENT OF REASONS**

Bedford Borough Council propose to make part of Wilkinson Road in Kempston a 'Bus Only Street' which will be enforced via the use of an ANPR camera.

This is intended to give buses priority through the local estate, encourage public transport usage, and encourage drivers to use more appropriate roads rather than this estate road as a short cut.

This is anticipated to achieve a reduction in the overall number of vehicles using this road, thus improving road safety for all highway users, including cyclists and pedestrians.





### Wilkinson Road, Kempston - Plan

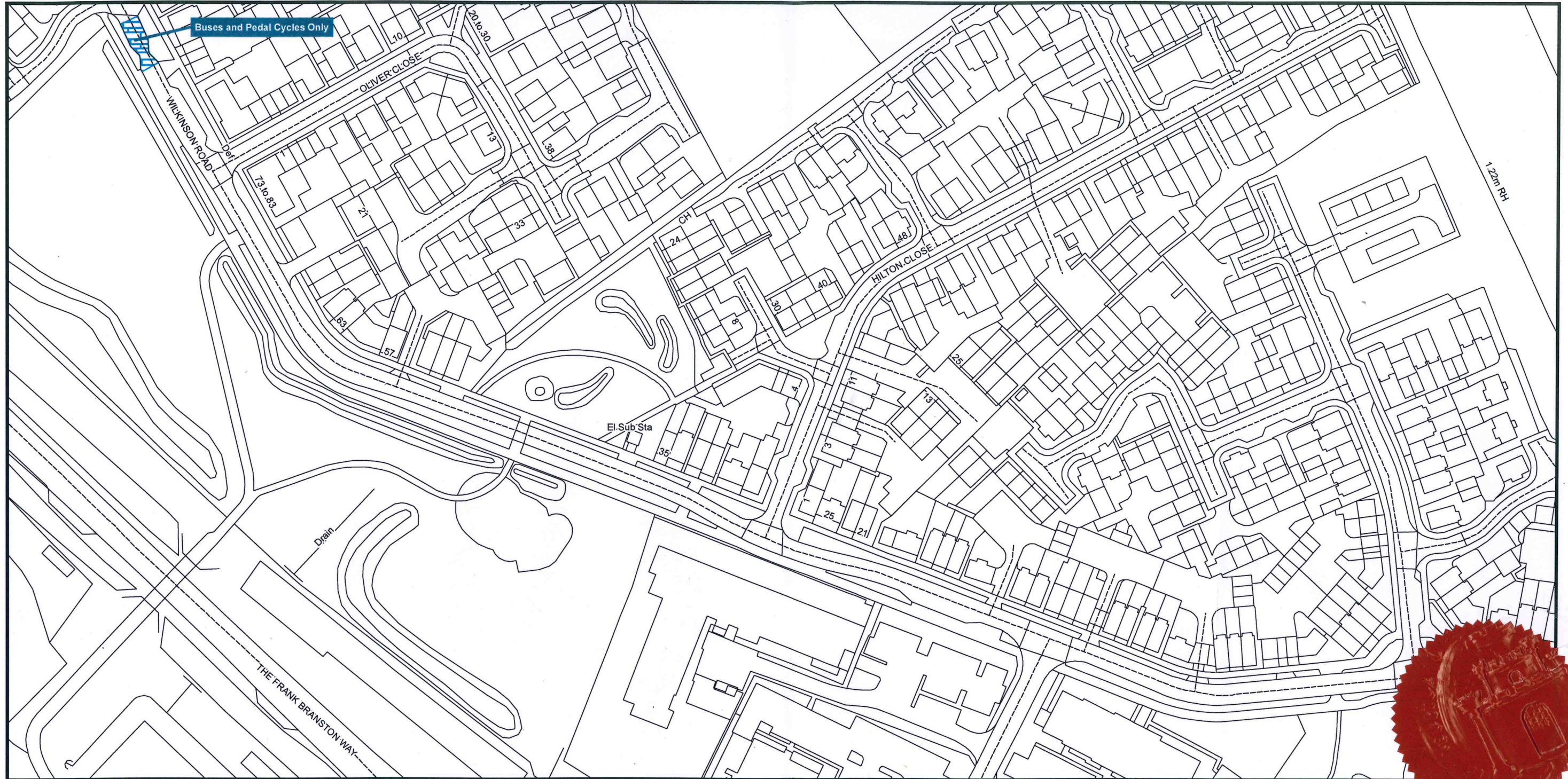
